#### TO: CUNY General Counsel & Senior Vice Chancellor for Legal Affairs Derek Davis

On November 3, 2022 I filed a conflict-of-interest/ethics complaint with CUNY/Craig Newmark Graduate School of Journalism Dean Graciela Mochkofsky, to which I have yet to receive ANY response, as of this date, seven months later.

By a May 2, 2023 e-mail to the J-School's General Counsel/FOIL Officer Richard White, I inquired as to the status of the complaint and whether – based on his response to a November 28, 2022 FOIL request and December 30, 2022 FOIL supplement I had filed – he was satisfied that all is as it should be at the J-School.

Rather than answering these two straight-forward questions, which requested not a single record, Mr. White falsely purported, by a May 3<sup>rd</sup> e-mail, that I had made a FOIL request for records as to the status of my complaint and my question based thereon:

"What kind of 'courageous and ethical journalism' does New York's taxpayer-supported J-School model and teach in its <u>own</u> New York City backyard when it steers its students <u>away</u> from investigating and reporting on a MAJOR corruption story pertaining to the New York City Council and New York City governance, involving, directly, the corruption of New York State governance – and this year's elections for governor, attorney general, comptroller and all 213 state legislative seats, 90-plus of which are for districts in New York City – whose consequence is that corrupt incumbents have now been re-elected or elected to other and higher offices." (bold and underlining in the original).

He thereupon denied the records request I had NOT made as "not subject to, or the purview of, NYS FOIL" and advised that if I "disagree with any ruling made in connection with this request", I could appeal to you, which is what I now do.

Please advise as to the status of my November 3<sup>rd</sup> conflict-of-interest/ethics complaint, including whether, notwithstanding <u>CUNY's Conflict of Interest Policy</u>, the complaint has fallen prey to individual and institutional conflicts of interest, and whether <u>you</u> are satisfied, based on Mr. White's response to my November 28<sup>th</sup> FOIL request and December 30<sup>th</sup> supplement, that everything is as it should be at the J-School.

Although Mr. White's May 3<sup>rd</sup> e-mail and my May 2<sup>nd</sup> e-mail are both below, as are my November 3<sup>rd</sup> complaint and my November 28<sup>th</sup> FOIL request, you can more easily review the situation from CJA's webpages pertaining to the complaint, here, and pertaining to the FOIL requests, here.

Finally, please advise as to whether you do not find it disturbing, in the extreme, that the J-School's "student powered" NYCity News Service posts NO reporting, at all, of this year's New York City Council and district attorney races, indeed, has only a tab for the "2022 election", whose content is paltry. This, notwithstanding I sent my May 2<sup>nd</sup> e-mail to a panoply of J-School recipients expressly to alert them to their duties, by their own "local journalism" and that of their students, to ensure investigative reporting of the New York City Council incumbents and the incumbent Bronx, Queens, and Staten Island D.A.s, running for re-election, whose flagrant corruption of their offices is established by the EVIDENCE underlying my November 3<sup>rd</sup> complaint. I am now expanding the J-School recipients to include John Mancini, who heads the NYCity News Service, and Jere Hester, who established the NYCity News Service in 2007, who, in addition to being acting director of the J-School's urban reporting program, is director of editorial projects and partnerships – undoubtedly including partnerships with The City, of which he was

"founding editor-in-chief", and the <u>Daily News</u>, where he had been city editor, neither publication engaged in ANY investigative journalism as to the records of City Council or D.A. incumbents concerning their mandated non-partisan, public integrity duties – or, seemingly, anything else.

In the event this e-mail to the J-School recipients bounces back, due to the block that Mr. White or someone else at the J-School has placed on e-mail from <a href="mailto:elena@judgewatch.org">elena@judgewatch.org</a>, I will re-send from <a href="mailto:elena.sassower@outlook.com">elena.sassower@outlook.com</a>.

Thank you for most recent email May 2, 2023.

As you may be aware, the Freedom of Information Law ("FOIL"), <u>Article 6 (Sections 84-90)</u> of the NYS Public Officers Law, provides the public right to access to records maintained by government agencies with certain exceptions.

"Record" means any information kept, held, filed, produced, or reproduced by, with, or for this agency, in any physical form whatsoever including, but not limited to, reports, statements, examinations, memoranda, opinions, folders, files, books, manuals, pamphlets, forms, papers, designs, drawings, maps, photos, letters, microfilms, computer tapes or disks, rules, regulations or codes. Specific responses to inquiries outside of the purview of FOIL are not required by law.

Specifically, in your latest email, under FOIL, you requested records pertaining to:

"What is the status of my November 3<sup>rd</sup> complaint that underlies the FOIL requests – and of my question based thereon:

What kind of 'courageous and ethical journalism' does New York's taxpayer-supported J-School model and teach in its <u>own</u> New York City backyard when it steers its students <u>away</u> from investigating and reporting on a MAJOR corruption story pertaining to the New York City Council and New York City governance, involving, directly, the corruption of New York State governance – and this year's elections for governor, attorney general, comptroller and all 213 state legislative seats, 90-plus of which are for districts in New York City – whose consequence is that corrupt incumbents have now been re-elected or elected to other and higher offices." (bold and underlining in the original).

## TO: CUNY/Craig Newmark Graduate Journalism School General Counsel White

Until you re-sent me your February 17<sup>th</sup> e-mail yesterday, in response to my April 28<sup>th</sup> e-mail, I had not seen it. It was not in any of my inboxes – and I have no recollection of having deleted it.

I trust you would agree, as <u>CUNY's Vice Chancellor for Risk</u>, <u>Audit and Compliance</u>, that the reason FOIL is often handled through counsel's office is so that lawyers can be alerted to situations requiring examination and correction, not the least reason to avoid legal liability.

From my November 28<sup>th</sup> FOIL request and its <u>December 30<sup>th</sup> supplement</u>—and the answers and minimal records <u>your February 17<sup>th</sup> letter</u> and <u>attachment</u> furnished – was it your view that everything is as it should be at CUNY's Craig Newmark Graduate School of Journalism? And was it also your view that Dean Mochkofsky's willful failure to respond to <u>my November 3<sup>rd</sup> ethics/conflict-of-interest complaint</u> was proper – and, likewise, the willful failure to respond by those I appropriately *cc*'d on e-mails of <u>November 10<sup>th</sup></u> and <u>November 17<sup>th</sup></u>, inquiring about the complaint, yourself among them. What is the status of my November 3<sup>rd</sup> complaint that underlies the FOIL requests – and of my question based thereon:

"What kind of 'courageous and ethical journalism' does New York's taxpayer-supported J-School model and teach in its <u>own</u> New York City backyard when it steers its students <u>away</u> from investigating and reporting on a MAJOR corruption story pertaining to the New York City Council and New York City governance, involving, directly, the corruption of New York State governance – and this year's elections for governor, attorney general, comptroller and all 213 state legislative seats, 90-plus of which are for districts in New York City – whose consequence is that corrupt incumbents have now been re-elected or elected to other and higher offices." (bold and underlining in the original).

Please advise as to both my FOIL requests and complaint – and do so as IMMEDIATELY as possible. Apart from everything else, the June 27<sup>th</sup> primaries for New York City's 51 City Council seats are fast approaching – and it is IMPERATIVE that the J-School belatedly discharge its duties, *via* its students' journalism and its professors' scholarship about, and participation in, New York's "local journalism", to ensure investigative reporting of the re-election-seeking City Council incumbents whose corruption underlies my November 3<sup>rd</sup> complaint to Dean Mochkofsky. The most important of these incumbents is City Council Majority Leader Keith Powers, chair of the Rules, Privileges and Elections Committee, before whom I testified on September 7<sup>th</sup> in the presence of J-School students Rand and Magrino – and about which they would have alerted their J-School professor, presumably NY-1's "Inside City Hall" host Errol Louis, who, in any event, I alerted. Next in importance are City Council Speaker Adrienne Adams, City Council Minority Leader Joseph Borelli, and Oversight and Investigations Committee Chair Gail Brewer. All three are members of the Rules, Privileges and Elections Committee and, like Majority Leader Powers, running for re-election.

As matters now stand, New York City citizens, whose taxes, with those of New York State taxpayers, pay for CUNY and its J-School, cannot meaningfully exercise their votes with respect to incumbent City Council members, ALL running for re-election except for one running against an incumbent Council member for his seat! Nor can they do so with respect to the three incumbent New York City district attorneys running for re-election, Bronx D.A. Darcel Clark, Queens D.A. Melinda Katz, and Staten Island D.A. Michael McMahon, who have each corrupted their offices to protect New York City's corrupt state legislators, covered-up by New York City's Conflicts of Interest Board, Department of Investigation, and Public Advocate Jumaane Williams, with NO oversight by the City Council. CJA's EVIDENTIARY webpage from which this is ALL accessible and readily-verifiable is here.

TIME IS OF THE ESSENCE. - (1) records reflecting the date on which the News Integrity Initiative, <u>publicly announced by CUNY J-School on April 3, 2017</u> and further elaborated upon by <u>Professor Jeff Jarvis' April 4, 2017 blog</u>, was <u>eliminated as "a stand-alone entity" and "refocus[ed]" to "improving diversity, equity, and inclusion (DEI) practices in the news business" and, additionally, the person who proposed same; the reasons therefor; the persons who approved it; and CUNY J-School's public announcement about the change;</u>
- (2) records reflecting whether the News Integrity Initiative received further funding during its existence as a "stand-alone entity", over and beyond the initial \$14 million from philanthropists and other private funders;
- (3) records as to the amount of funding the New Integrity Initiative expended during its existence as a "stand-alone entity" and how much remained when it was eliminated and "refocus[ed]";

- (e) critical examination of such "legacy" press as the New York Times, New York Daily News, New York Post, Newsday, Gannett, Albany Times Union, Buffalo News, Syracuse Post-Standard and such other press as The New York Law Journal, The Wall Street Journal, City Journal, Bloomberg, Crains New York Business, Politico with respect to reporting on non-partisan, public integrity, and constitutional issues pertaining to New York State and New York City governance and the records, in office, of incumbent public officers.

#### TO: CUNY Craig Newmark Graduate School of Journalism Dean Graciela Mochkofsky

Yet another week has passed – and I have received no response from you to my below November 10<sup>th</sup> email, nor any responses from the 16 other J-school recipients, 12 of whom are administrators or faculty and the other 4 students.

Is there any explanation for this other than a multitude of institutional and individual conflicts of interest impacting upon the discharge of your duties with respect to my November 3<sup>rd</sup> conflicts-of-interest/ethics complaint – and with respect to answering the straight-forward questions asked by my November 10<sup>th</sup> email, the most important, in bold type and with underlining for added emphasis:

"What kind of 'courageous and ethical journalism' does New York's taxpayer-supported J-School model and teach in its <u>own</u> New York City backyard when it steers its students <u>away</u> from investigating and reporting on a MAJOR corruption story pertaining to the New York City Council and New York City governance, involving, directly, the corruption of New York State governance – and this year's elections for governor, attorney general, comptroller and all 213 state legislative seats, 90-plus of which are for districts in New York City – whose consequence is that corrupt incumbents have now been re-elected or elected to other and higher offices."

To assist you in articulating such explanation as you have, I am now *cc*'ing the J-School's "Ethics Officer", Geraldine Powell, who, according to CUNY's webpage entitled "State Ethics In Public Service and at CUNY", is available to guide you and, "as appropriate, consult the OGC [Office of the General Counsel of The City University of New York] on behalf of the institution." This same webpage posts CUNY's own Conflict of Interest Policy and, by identifying that CUNY employees are "state employees...bound by the New York State Public Officers Law and New York State ethics regulations, enforced by "the New York State Commission on Ethics and Lobbying in Government (formerly known as the New York State Joint Commission on Public Ethics)", has revealed a further conflict of interest. Indeed, the corruption of these two state ethics enforcement entities is directly part of the "MAJOR corruption story" -- and so-reflected by my above testimony that I presented and endeavored to present at the City Council's September 7, 2022 "advice and consent" confirmation hearing, in the presence of students Rand and Magrino and which they presumably embodied in some "journalism" and furnished to their professor(s), together with my entreaties for investigative reporting, if not by them, then by other J-school students – and as immediately as possible because of its decisive significance to the 2022 elections, early-voting for which was then more than seven-weeks away.

As the J-School is not only under the ethics jurisdiction of the Commission on Ethics and Lobbying in Government, but, additionally, the New York State Inspector General — a fact highlighted by the January 28, 2020 memorandum entitled "Protocol for Reporting Allegations of Corruption, Fraud, Criminal Activity, Conflicts of Interest or Abuse" by CUNY Vice Chancellor for Risk, Audit and Compliance Richard R. White, who also serves as the J-School's General Counsel, I am cc'ing him as well.

Subject: AGAIN -- Ethics Violations by CUNY/Craig Newmark Graduate School of Journalism Students Rebecca Rand & Nicolas Magrino -- & Adjunct Professor Errol Louis -- PLUS FURTHER QUESTIONS

# TO: CUNY Craig Newmark Graduate School of Journalism Dean Graciela Mochkofsky

A week has elapsed since I sent you my below November 3<sup>rd</sup> e-mail entitled: "Ethics Violations by CUNY/Craig Newmark Graduate School of Journalism Students Rebecca Rand & Nicolas Magrino – & Adjunct Professor Errol Louis". I have received no acknowledgment or response.

Have you referred it to the Faculty-Student Disciplinary Committee, which, pursuant to Article IV, §C(4) of the Governance Plan, is "charged with considering violations of the Newmark J-School's Code of Ethics"? As I have not been contacted by it, I am *cc*'ing its <u>chair and members</u> so that they can apprise me of how my <u>fully-documented</u> November 3<sup>rd</sup> ethics complaint, with its above four attachments, will be handled.

I am also *cc*'ing the two J-School faculty members whose names come up on a keyword search of "ethics" on the J-School's website, as I believe review of ethics complaints should include ethics teachers. They are <u>Adjunct Professor David Bralow</u> and <u>Adjunct Professor David Kaplan</u>, each teaching the required first semester course "<u>Legal and Ethical Issues</u>" (Jour71103). Quite possibly first semester students Rand and Magrino are their students.

Additionally, I am *cc*'ing <u>Associate Dean Andrew Mendelson</u> and <u>Interim Assistant Dean for Administration Amy Dunkin</u>, the latter having authored the J-School's December 7, 2017 announcement "<u>CUNY J-School to Help Oversee an Award for Courageous and Ethical Journalism</u>" – both serving, with you, on the <u>Governance Council</u>, chaired by <u>Associate Professor Judith Watson</u>, also *cc*'d.

What kind of "courageous and ethical journalism" does New York's taxpayer-supported J-School model and teach in its <u>own</u> New York City backyard when it steers its students <u>away</u> from investigating and reporting on a MAJOR corruption story pertaining to the New York City Council and New York City governance, involving, directly, the corruption of New York State governance – and this year's elections for governor, attorney general, comptroller and all 213 state legislative seats, 90-plus of which are for districts in New York City – whose consequence is that corrupt incumbents have now been re-elected or elected to other and higher offices.

Please also advise as to who are the J-School professors engaged in <u>scholarship</u> of press performance, as the conduct of students Rand and Magrino <u>replicates</u> that of New York's press, of which the J-School's faculty is part and has financial and other ties. Do ethics instructors Bralow and Kaplan consider themselves <u>scholars of press performance</u> – and are they so-considered by the J-School? If not, who are the J-School's scholars who engage in <u>unbiased</u>, <u>methodologically-sound research and analysis of press performance</u>?

Unfortunately, the J-School scrapped its <u>News Integrity Initiative</u>, announced on April 3, 2017 as a \$14 million philanthropically-funded "joint effort to advance news literacy and increase trust in journalism",

quietly replacing it at some point subsequent to the October 2019 J-School Self-Study Report for Accreditation in Journalism and Mass Communications (see pp. 27, 29, 36, 126). It is now euphemistically "refocus[ed]" to "improving diversity, equity, and inclusion (DEI) practices in the news business". Is this because any true News Integrity Initiative, guided by evidence, would have to confront the rightful causes of public distrust in journalism, such as those to which I can attest from direct, first-hand experience and substantiate by an archive of primary-source, documentary evidence spanning 30-plus years, to wit, the press' total non-responsiveness to serious, substantial, and repeated complaints about its agenda-driven, knowingly false and misleading reporting and editorializing, willfully covering up governmental corruption and rigging elections, all the while trumpeting its integrity.

Also, please advise why, with lawyers such as Adjunct Professors Bralow, Kaplan, and Louis on the J-School faculty, the J-School has no concentration in legal journalism and reporting on the courts. In any event, who are the professors teaching these vital subject areas?

I note that on March 24, 2022 the J-School announced a Criminal Justice Reporting Initiative, whose kickoff was "woke" agenda-driven training session about police killing, police corruption, and police coverup. Has the referred-to 14-week "Criminal Justice Reporting Lab", announced for the fall semester presumably still ongoing – been training students to follow the "paper trail" of corruption by the higher, more powerful participants of the Criminal Justice System: the judges, district attorneys, and other public prosecutors – and to expose the corruption of such complaint mechanisms to hold them accountable as the New York State Commission on Judicial Conduct and New York's court-controlled attorney grievance committees. And what about a corresponding Civil Justice Reporting Initiative? Will the J-School be training students to investigate and report on the comparable fashion in which the Civil Justice System operates - with corrupt judges and lawyers, such as now re-elected New York State Attorney General Letitia James, whose litigation fraud in defense of corrupt public officers, herself among them, and pertaining to the corruption of constitutional state governance involving pay raises and the state budget, is fully-documented in complaints to the First Department Attorney Grievance Committee, featured and linked by my above-attached September 7th testimony against City Council confirmation of Mayor Eric Adams' appointment of the now chair of the New York City Conflicts of Interest Board, Milton Williams, Jr., Esq., whose two-minute oral synopsis students Rand and Magrino heard me present at the City Hall hearing – and whose expanded written version I gave them, in hand. Presumably, they produced some "journalism" for the J-School professor for whom they were at the City Hall hearing in fulfilment of a class assignment. Was that Adjunct Professor Louis, to whom I sent the testimony by my below October 23rd e-mail, and who, doubtless and in addition to his other conflicts of interests, has years of personal and professional relationships with Mr. Williams, Attorney General James, Mayor Adams, and with New York City Public Advocate Jumaane Williams - all, like himself, black - impacting his "courageous and ethical journalism".

Please let me hear from you, as soon as possible. Are you available for a conversation – or, in the words of the defunct News Integrity Initiative, "respectful civic discourse", which the J-School, based on News Integrity Initiative research, also refers to as "engagement journalism", for which, since 2021, it offers an M.A. degree.

## TO: CUNY Craig Newmark Graduate School of Journalism Dean Graciela Mochkofsky

I hereby seek enforcement of the <u>Code of Ethics</u>, which students of the CUNY Craig Newmark Graduate School of Journalism are required to "read, sign, and heed" – and whose violations subject them to "appropriate sanctions, up to and including expulsion, in accordance with CUNY Bylaws and the CUNY Policy on Academic Integrity and professional journalism standards." Presumably, professors are also required to adhere to, if not sign, a comparable Ethics Code – and face punishment including discharge, for cause.

At issue is misconduct, born of conflicts of interest, by students Rebecca Rand and Nicolas Magrino – and by their journalism professor for whom, in fulfillment of an academic requirement/class assignment, they were at a September 7<sup>th</sup> confirmation hearing at City Hall. Such professor may have been Adjunct Professor Errol Louis, but, irrespective, his misconduct born of conflicts of interest is additionally at issue based on my below October 31<sup>st</sup> and October 23<sup>rd</sup> e-mails with the above four attachments, sent to him and to students Rand and Magrino, without response from any of them.

I am available to be interviewed, including under oath. Please advise as to your complaint "process".

Dear Rebecca & Nicolas,

How surprising to have received no responses from you to my two <u>September 8<sup>th</sup> e-mails</u> & <u>here</u>, my <u>September 12<sup>th</sup> e-mail</u>, and my below <u>September 13<sup>th</sup> e-mail</u>, with the above-attached, furnishing you with a MAJOR corruption story pertaining to the New York City Council and New York City governance, involving, directly, the corruption of New York State governance – and this year's elections for governor, attorney general, and comptroller and all 213 state legislative seats, 90-plus of which are for districts in New York City, which I discussed with you, face-to-face, on September 7<sup>th</sup>, at City Hall, before and after my two-minute oral testimony in opposition to confirmation of Milton Williams, Jr., as chair of the New

York City Conflicts of Interest Board, and the preclusion of my two-minute oral testimony in opposition to Anthony Crowell's confirmation to the New York City Planning Commission.

Please explain why you did not respond, including as minimally as confirming that you "furnished my September 7<sup>th</sup> testimony and my proposal for your follow-up investigative reporting to your journalism professors" and "who they are, so that I might contact them directly".

AS TIME IS OF THE ESSENCE, I am *cc*'ing <u>Errol Louis</u>, whose faculty bio at CUNY's Craig Newmark Graduate School of Journalism identifies that he is "host of NY1's 'Inside City Hall,' the preeminent political news show in New York City", so that he can identify whether you are his journalism students — and, if not, whether he was alerted to the corruption story that you were not pursuing by the professor for whom, in fulfilment of an academic requirement/assignment, you were at the City Hall hearing, presumably thereafter producing some kind of journalism about what you had seen and heard on September 7<sup>th</sup> — and which, in the complete absence of any reporting by New York City Hall reporters, who presumably had the live-stream and subsequent video, resulted in the City Council's September 14<sup>th</sup> confirmation of the nominees. Here is <u>CJA's webpage posting the video and transcript links and the evidentiary trail of public corruption at the City Council preceding it which your journalism professor should have expected you to pursue, immediately, or, just as immediately, passed on to other journalism students and relevant faculty for investigative reporting so that culpable and collusive City Council members were held to account, including in <u>next year's election to the City Council</u> and prevented from obtaining other offices of public trust.</u>

I ask for your responses – and for Mr. Louis' – by no later than tomorrow morning, as thereafter I will be communicating with both new <u>Dean Graciela Mochkofsky</u> and <u>benefactor Craig Newmark</u> about how <u>New York's taxpayer-funded CUNY</u> graduate journalism school has been operating – steering students **away** from non-partisan journalism that exposes public corruption by public officers and, in so-doing, rigging both the re-election of corrupt incumbents and the election of collusive successors and challengers. Such is clearly the product of undisclosed conflicts of interest, including between the New York press which operates in precisely this fashion and the J-school's faculty and <u>its former dean, the now Dean Emerita Sarah Bartlett</u>, who are, or have been, part of the press. Apparently, this behavior, together with a disregard of the most basic decencies, is being inculcated in journalism students, such as yourselves

CJA's webpage posting my prior attempts to secure non-partisan, electorally-relevant, corruption-exposing journalism by CUNY's Craig Newmark Graduate School of Journalism and its <a href="NYCity News">NYCity News</a> Service, which I briefly described to you, is <a href="here">here</a>.

#### **TO: New York City Council FOIL Officer Danielle Barbato**

Pursuant to FOIL, this is to request records, including of governing rules and procedures, pertaining to the <u>September 7, 2022 hearing of the Committee on Rules, Privileges and Elections for its "advice and consent" on five of Mayor Adams' appointees – and, specifically, records:</u>

(1) reflecting why the "Committee Report of the Committee on Rules, Privileges and Elections", made publicly available at the September 7, 2022 hearing, prominently identifies "Office of the General Counsel, Jason A. Otano, General Counsel" – implying that the Office of General Counsel has a role – and whether its role includes ensuring compliance by the City Council with express standards in the New York City Charter for appointees, identified in the "Committee Report";

- (2) reflecting whether the "Committee staff" identified at the top of the "Committee Report" as "Jeffrey Campagna, Committee Counsel; Pearl Moore, Ethics Counsel; Francesca Della Vecchia, Director of Investigations; Alycia Vasell, Compliance Investigator; Ramses Boutin, Legislative Investigator" are actually staff of the Office of the General Counsel;
- (3) reflecting why members of the public were not called up to testify immediately after each appointee with the appointee expected to respond thereto;
- (4) reflecting why Rules Committee Chair Keith Powers was the only member of the Committee present for the public's testimony, relegated to the end of the hearing – and, beside him, "Committee Counsel" Campagna;
- (5) reflecting why the City Council's webpage for public testimony, https://council.nyc.gov/testify/, does not identify a two-minute limit for oral testimony by members of the public – or that oral testimony concerning more than a single appointee at a given hearing will not be afforded, as to each appointee, two minutes;
- (6) reflecting whether there is any precedent for what Rules Committee Chair Powers did in denying me two minutes to testify as to each of the two appointees for whom, prior to the hearing, I had submitted two separate registrations;
- (7) reflecting what investigation was done and by whom -- <u>prior to the hearing</u> of my e-mails pertaining to the unfitness of Milton Williams, Jr., Esq., appointed chair of the New York City Conflicts of Interest Board, and Anthony Crowell, Esq., appointed to the New York City Planning Commission;
- (8) reflecting what investigation was done and by whom -- <u>subsequent to the hearing</u> of my written and oral testimony in opposition to Messrs. Williams and Crowell and whether findings of fact have been made with respect thereto;
- (9) reflecting whether my written testimony, sent to the City Counsel, including directly to Counsel Campagna and to Rules Committee Chair Powers <u>prior</u> to the hearing, was distributed to Committee members <u>prior</u> to the hearing;
- (10)reflecting whether, at tomorrow's Rules Committee meeting at which the mayor's five appointees are on the agenda, counsel and investigative staff will be presenting Committee members with findings with respect to my opposition testimony, including as to whether, based on the evidence, Messrs. Williams and Crowell can be confirmed consistent with the Charter's express standards – and whether the meeting will be live-streamed or recorded;

- (11)reflecting whether, prior to the City Council's session and vote on the appointments, the City Council members will be alerted to my written opposition testimony to Messrs. Williams and Crowell and findings made with respect thereto and whether the session will be live-streamed or recorded;
- (12) reflecting when was the last time that either the Rules Committee or City Council rejected an appointee.
