The White House has, apparently, NOT picked up an EXPRESS MAIL letter that I sent to it on January 5, 2015 in an envelope addressed to the President's counsel, W. Neil Eggleston. According to the tracking [EK 524727349 US], it was delivered to the post office on January 6, 2015 and has been "available for pick up" since 10:54 a.m. on that date – FOUR DAYS AGO.

Fortunately, the letter is posted on the website of our nonpartisan, nonprofit citizens' organization, Center for Judicial Accountability, Inc., [www.judgewatch.org](http://www.judgewatch.org), accessible *via* the prominent homepage link: "CJA's Citizens' Opposition to Senate Confirmation of US Attorney Loretta Lynch as US Attorney General" – and I so-informed the White House in a voice mail message I left for the President's counsel on Monday morning, January 5, 2015.

Please advise why the EXPRESS MAIL envelope has not been picked up. If the problem is that you do not give signature confirmations – which is what I requested on the EXPRESS MAIL label – this should be so-stated on the White House website. It is not.

ALSO, your limited "Subject" options for this message do NOT include "Nominations", nor even "Justice". What "Subject" option would you have me use for this message? The closest would seem to be "Civil Rights".

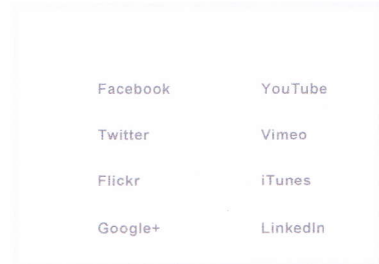

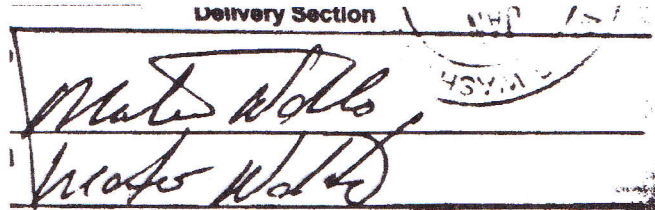

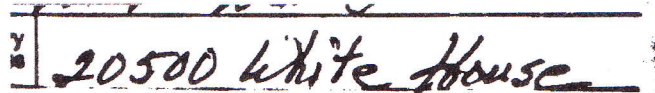
