RECORDS REQUEST: The Amendment to Budget Bill #A.8551 – and the Memo

appearing on the Assembly's Webpage for Bill #A.8551A

Following up our phone conversation this morning, I would appreciate your response, at your earliest convenience, to CJA's February 11, 2014 records request entitled:

"The Governor's Introducer's Memoranda for his Article VII Judiciary and Legislative Budget Bills:

#A.8551/S.6351 (2014) – third phase of the judicial salary increase; #A.3001/S.2601 (2013) – second phase of judicial salary increase; #A.9051/S.6251 (2012) – first phase of judicial salary increase."

As discussed, at the time I made that February 11, 2014 records request, neither the Assembly nor Senate had any memo posted on their webpages for Budget Bill #A.8551/S.6351. Each webpage identically stated: "Memo not available", as may be seen from the enclosed print-outs made on March 25, 2014.

As may be seen from the enclosed print-outs made today, the Assembly and Senate webpages now each identify that the bill was amended on March 28, 2014 – though not what the amendment consisted of. The Assembly webpage also now posts a memo, though it is unclear whether this is a memo for the original 8551 or for 8551A.

Pursuant to Assembly Rule VIII, "Public Access to Records", please furnish all publicly-available records pertaining to the amendment and the memo.

The relevant Assembly Rules appear to be:

Assembly Rule III, §6 entitled "Amendments", which states, in pertinent part:

"a. No amendment to a bill may be offered unless the member proposing the amendment delivers three copies of the bill with the proposed amendment correctly marked thereon and six copies of the detailed description of such amendment to the Clerk of the Assembly. b. A copy of each amendment offered by the sponsor of a bill shall be provided by Journal Operations to the chairperson and ranking minority member of any standing committee that previously reported such bill...."

and Assembly Rule III, §1(f) entitled "Introducer's memorandum", which states, in full:

"There shall be appended to every bill introduced in the Assembly, an introducer's memorandum setting forth the purpose of the bill, a summary of its provisions, a statement of its fiscal impact on the state, a statement of its impact on the regulation of businesses and individuals and a statement as to whether the bill imposes or changes any fine, term of imprisonment, forfeiture of rights or other penal sanction, together with the nature of such imposition or change in a format and length to be prescribed by the Speaker. Whenever a bill is amended by its sponsor, it shall be the duty of the sponsor to file an amended memorandum setting forth the same material as required in the original memorandum. In addition, whenever a bill is reported by a committee as amended, it shall be the duty of the committee to submit an amended memorandum." (underlining added).
