Dear U.S. Attorney Bharara,

As you know, the Commission to Investigate Public Corruption violated Governor Cuomo's Executive Order #106 that established it in many respects – several of which are particularized by my April 23, 2013 affidavit in support of my order to show cause to intervene in the Legislature's declaratory judgment action vs the Commission. Among these, the Commission's violation of the requirement, in ¶IX, of public hearings. In mandatory language, it states:

“The Commission shall conduct public hearings around the State to provide opportunities for members of the public and interested parties to comment on the issues within the scope of its work.” (quoted at ¶44 of my April 23, 2013 affidavit in support of my order to show cause to intervene & discussed at ¶¶45-57).

Heather Green, whose testimony you are requiring today by a grand jury subpoena, has a great deal of information to offer about the public hearings.

On September 17, 2013, just hours before the Commission's first public hearing – at which you, US Attorney Lynch, and Manhattan DA Vance testified first and at length – it was Ms. Green who e-mailed untold numbers of members of the public who had requested to testify, informing them they would not be permitted to do so.

If you have not already secured such e-mails entitled “Tonight's Moreland Hearing”, attached is an illustrative sampling of Ms. Green's e-mails to would-be witnesses Suzanne McCormick, Anthony Pappas, Vladislav Ruchinsky, Terence Finnan, Kathleen Cole (*via* her attorney Eric Su, Esq.). Included therein is the response that Mr. Ruchinsky sent back to Ms. Green, upon receiving her e-mail, as well as the comment that Mr. Finnan sent to me: “Message received on 9/17 which was sent at 3:29 PM and unlikely to be immediately received nor read when the doors open at 5PM. Pure corruption”. Each of these would-be witnesses are listed on CJA's website, www.judgewatch.org, on a webpage about the hearings entitled: “The People Have Something to Say & Evidence to Back it Up”. Our webpage for Mr. Pappas posts his further elaborating comment about his experience, which is, as follows:

“I requested to testify at the September 17th hearing of the Commission to Investigate Public Corruption, in Manhattan, registering through the Commission's website and indicating that my testimony would relate to due process and the courts. I don't recall the precise date, but thereafter telephoned the Commission, twice, each time speaking with Bryce Jones of the Commission staff, who told me I was on the list of speakers.

Based thereon, I travelled to Pace University in Manhattan where the hearing was being held – a trip that took me an hour. However, when I arrived, I was told my name was not on the list of speakers and was refused admittance.

Upon returning home, I found an e-mail from the Commission, sent at 3:29 that afternoon, after I had already left to go to the hearing. It stated that the list of topics for

speakers was limited to three topics and that I would not be permitted to testify because my proposed testimony was not among the group of three approved topics. The e-mail is below..."

Ms. Green was also on-site, outside the September 17, 2013 hearing in Manhattan – as recounted by the reporting of Will Galison, as follows:

"When the first Commission hearing was held on September 17, 2013 about a hundred people gathered at the entrance of Pace University in Lower Manhattan to testify. The excitement was palpable among the crowd that waited behind police barricades for the opening of the hearings at 6:00 PM. But at about 5:45, Commission staffer Heather Green walked along the barricade, asking the witnesses their names. In almost every case, she then glanced at her clipboard, shook her head and announced, 'I'm sorry, you're not on the list'. No explanation was given as to why dozens of people who said they had registered, and in some case travelled hours to testify, were "not on the list", and the witnesses' frustration gave way to anger and some near-altercations..." (underlining added, "The Moreland Commission Exposed", <http://morelandcommssiononpubliccorruption.blogspot.com/>).

After the September 17, 2013 hearing, Ms. Green sent out e-mails on September 23, 2013, to those who had registered for the September 24, 2013 Albany hearing, identifying that it was to be limited to "Campaign finance; Outside income of state elected officials; and political housekeeping accounts". Gary Jacobs was among those receiving that e-mail. Like so many others, his prospective testimony was not about these topics and a mere five days earlier, on September 18, 2013, Ms. Green had personally e-mailed, him – and not as a form e-mail "...We will list you as one of the testifiers for next week's hearing...." Mr. Jacobs annotated Ms. Green's September 23, 2013 e-mail when he forwarded it to me with the comment: "What a scam! I am not going".

Like many other would-be witnesses, Tracy Egan had unsuccessfully sought to testify at both the Manhattan and Albany hearings. She wrote Ms. Green, on October 24, 2013, stating:

"I am writing to request a meeting with the Moreland Commission, or at least a few members. I request one on behalf of a group of NY citizens who have suffered from the very corrupt Laura Drager. We have suffered years, our families have been ravaged, many of us have been before Laura Drager for 5, 8, even over 10 years.

...

There are between 8-15 women who would like to come in for a meeting to discuss and present the irrefutable corruption evidence we have against Laura Drager. I know some of us have already submitted evidence to the Commission..."

There was no response to this meeting request. Instead, Ms. Egan received a form letter dated November 7, 2013, from the Commission. It was identical to what other would-be witnesses received, on that same date, including would-be witness Dan Drennen whose October 3, 2013 e-mail to me recited that he had sent Ms. Green "a lot" of e-mail. Tailored by Ms. Egan's name, and thanking her for "correspondence dated 10/13/2013 regarding judicial corruption", it falsely made it appear that what she had already furnished "regarding judicial corruption" had not been responsive to the Commission's investigative mandate, under Executive Law 106 of "investigating...weaknesses in existing laws, regulations and procedures related to...public corruption, conflicts of interest and ethics in State Government."

Finally, with respect to the stenographic transcript of my September 17, 2013 testimony before the Commission, I had two phone conversations with Ms. Green about the pattern of errors in the stenographic transcription of my testimony, material to my presentation as to the Commission's conflicts of interests. These conversations, on December 4th and December 16th, related to my October 25, 2013 letter to the president of the transcription company – and the President's response to me, *to wit*, that the Commission had told her not to make any corrections in the transcript and

that anyone inquiring about transcripts should call the Commission. These conversation are recited at ¶194 of my April 23, 2014 verified complaint in support of my order to show cause to intervene in the Legislature's declaratory judgment action vs the Commission – and Ms. Green is the referred-to "office manager", therein not identified by name, who stated that someone would be getting back to me. No one ever did. For your convenience, the October 25, 2013 letter, which is Exhibit M, to the proposed verified complaint, is attached.

To further assist you, I will post this e-mail – and its evidentiary substantiation – on a webpage entitled "Assisting U.S. Attorney Bharara Live Up To His Rhetoric", albeit blacking out names of would-be witnesses who have requested confidentiality. The webpage is part of our collection of webpages entitled "Exposing the Fraud of the Commission to Investigate Public Corruption", accessible *via* our homepage, www.judgewatch.org. Please let me know when you will be calling me in to give a statement to your investigators under oath – or when you would like me to appear before a grand jury – to furnish testimony as to my direct, first-hand knowledge – and documentary proof – of the Commission's corruption, covering up the corruption of a who's who in New York State government, beginning, at the top, with Governor Cuomo, Attorney General Schneiderman, Comptroller DiNapoli, and the Legislature's Leadership, first and foremost, Temporary Senate President Skelos and Assembly Speaker Silver, all up for re-election.

I am writing to request a meeting with the Moreland Commission, or at least a few members. I request one on behalf of a group of NY citizens who have suffered from the very corrupt Laura Drager. We have suffered years, our families have been ravaged, many of us have been before Laura Drager for 5, 8, even over 10 years.

Laura Drager has received abundant press for 15 years about her extreme corruption and her collusion with some of the "biggest" law firms in NY. It is well established that she works with certain players including, but not limited to, lawyers, forensics, attorneys for the child, accountants etc.

There are dozens of us, we have separately gone to the CJC, AG, DA, Fern Fisher, Sherry Heitler, Mayor Bloomberg, Gail Prudenti, the Inspector General of Courts, the FBI etc. Every single safety mechanism to safeguard the public against this rogue, corrupt judge has failed. Everyone is protecting Laura Drager and refusing to address her overt, brazen and documented corruption.

There is a petition online (signed by hundreds of us) that was sent to the CJC in August. We requested investigations into our individual cases, yet the CJC refused to investigate.

The council representative - Micah Kellner - for the UES is waiting for Heitler to retire - he has worked tirelessly to get Drager out of office before she does more damage to the nonmonied spouses and kids. He has manifold complaints which he belives against this tyranical woman.

I contacted the Inspector General, Liz Candreva, this summer after my transcripts were altered again. I submitted affidavits from two court watchers, I submitted my own.

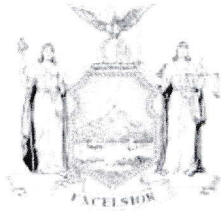
At first Mrs Candreva was willing to investigate and told me she would open an investigation. Two months later and the IG wants to fob this back to Drager to investigate. I responded why would I want the criminal who orchestrated the transcript tampering to investigate? My hearing was a mere 28 pages, how hard is it to pull the original stenographer notes to compare? Maybe 30 minutes? This is outrageous and antithetical to logic. My ex is a convicted felon, a former biglaw name partner who is illegally owning and running the Khan Swift & Foti law firm, despite his disbarment. He already went to jail for RICO once.

The transcript example is one tiny example in my case. I have 6 pages of decisions over 8 years where Drager ruled outside of law, always favoring my opposition, to save him money despite laws and stipulations which should be protecting our daughter. I never even married my ex, we are a custody case, and my ex illegally procured Laura Drager by fraud, submitting documents stating we were a "contested matrimonial." All irrefutable evidence of corruption in our case is ignored.

There are between 8-15 women who would like to come in for a meeting to discuss and present the irrefutable corruption evidence we have against Laura Drager. I know some of us have already submitted evidence to the commission.

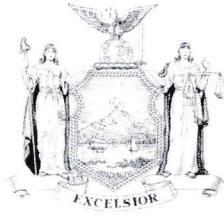
