These conversation are recited at ¶94 of my April 23, 2014 verified complaint in support of my order to show cause to intervene in the Legislature's declaratory judgment action vs the Commission — and Ms. Green is the referred-to "office manager", therein not identified by name, who stated that someone would be getting back to me. No one ever did. For your convenience, the October 25, 2013 letter, which is Exhibit M, to the proposed verified complaint, is attached.

To further assist you, I will post this e-mail — and its evidentiary substantiation — on a webpage entitled "Assisting U.S. Attorney Bharara Live Up To His Rhetoric", albeit blacking out names of would-be witnesses who have requested confidentiality.
