RECOMMENDATION TO THE EXECUTIVE, CONGRESSIONAL AND GUBANATORIAL OFFICERS AND THE STATEWIDE COMMISSION ON DISCIPLINE THAT (I) JUDICIAL AND ATTORNEY DISCIPLINE AND CHARACTER COMMITTEES BE ABANDONED, DISSOLVED AND TERMINATED AS INSTRUMENTS OF (1) RETALIATION AND (2) CRIMINAL CONSPIRACY AND (II) CRIMES COMMITTED BY FEDERAL, STATE AND MUNICIPAL JUDICIARY AND ATTORNEY OFFICERS BE MADE CLASS A-E FELONIES UNDER FEDERAL AND STATE LAW AND BE KNOWN AS THE ASTOR/SASSOWER/GOLDBERG/WEISSHAUS ACTS OF 2016

Dean Loren, Esq. requests consideration of President Barack Obama, Representative John Boehner, Speaker of the House, of the United States of America, and the Governors Nationwide that in light of the Bernard and Emily Madoff Billion Dollar Ponzi Scheme also known as "Emily's List" - perpetuated for (a) (i) the theft of Estates in State Probate Courts in Massachusetts, New York, and States Nationwide by targeting seniors with Guardianships, Guardian ad litem, and instruments of state ward ship, and (ii) Class Actions (b) the purposeful failure of State and Municipal Public Schools Systems for the transfer and theft of public tax paid real estate to non-profit charter organizations ownership, (c) financial gain by using ill-gotten and stolen funds as seed money for construction loans in and around targeted Title 13 Public School Real Estate, (d) funding of campaign treasuries benefitting prosecutorial offices or federal, state and municipal elected offices with the power to nominate/appoint prosecutors and judges, and protection of law firms (e) retaliation against whistleblowers of ponzi scheme actors hereby recommends (I) the abandonment, dissolution and termination of Federal, State and Municipal Judicial and Attorney Disciplinary and Character Committees nationwide as instruments of (1) retaliation, (2) criminal conspiracy, and (II) Crimes committed by federal, state and municipal judiciary and attorney officers be made Class A-E Felonies under Federal and State Law and be known as the:

ASTOR/SASSOWER/GOLDBERG/WEISSHAUS REFORMATION ACTS OF 2016.
