### Jason Laidley/Chief of Staff to 1<sup>st</sup> Term Senator Bailey –

I want to again thank you for our phone conversation together earlier this afternoon. I was pleased to have had the opportunity to summarize important responsibilities that Senator Bailey will have as ranking member of the Senate Committee on Crime Victims, Crime, and Corrections – for which he gets a \$9,000 “lulu” -- and, additionally, as member of the Senate Judiciary Committee and the Senate Codes Committee. As discussed, our non-partisan, non-profit citizens’ organization, Center for Judicial Accountability, Inc. (CJA), has a wealth of EVIDENCE germane to the Senator’s work on these three committees – accessible from our website, [www.judgewatch.org](http://www.judgewatch.org).

I consider it especially fortuitous that Senator Bailey has spent many years working for Assembly Speaker Heastie – as Assembly Speaker Heastie is in need of someone who can give him an “honest read” of the significance of what I have been endeavoring to bring to his attention, without success. These are laid out by the documents accessible from the two homepage links I guided you to: “CJA’s Citizen-Taxpayer Actions to End NYS’ Corrupt Budget ‘Process’ & Unconstitutional ‘Three Men in a Room’ Governance” –whose direct link is here: <http://www.judgewatch.org/web-pages/searching-nys/budget/menu-budget-reform.htm> -- and “No Pay Raises for New York’s Corrupt Public Officers – The Money Belongs to their Victims!” – whose direct link is here: <http://www.judgewatch.org/web-pages/judicial-compensation/2015-no-pay-raises-menu.htm>.

Actually, Senator Bailey should start first with the second link pertaining to the pay raises– as it furnishes the background from which to better understand the first. I already showed you my January 15, 2016 letter to Assembly Speaker Heastie and Temporary Senate President Flanagan, accessible *via* that second link. I received no response from the Assembly Speaker to the letter – and his disregard of it and of my succession of other correspondence in 2016, laid out on that page, underlies CJA’s second citizen-taxpayer action, commenced on September 2, 2016, to which he is a named defendant: <http://www.judgewatch.org/web-pages/searching-nys/budget/citizen-taxpayer-action/2016/9-2-16-osc-complaint/9-2-16-osc-verified-complaint.htm>. That citizen-taxpayer action, pertaining to the current fiscal year, 2016-2017, particularizes a succession of crimes committed by New York’s government and its highest public officers against the People – involving judicial pay raises, district attorney pay raises, the legislative and judiciary budgets, and the executive budget.

That plaintiffs have established their entitlement to summary judgment, *as a matter of law*, on all ten causes of action of their September 2, 2016 verified complaint is clear from the posted record – and Senator Bailey can easily determine this for himself from plaintiffs September 30, 2016 memorandum of law, summarizing

the record: <http://www.judgewatch.org/web-pages/searching-nys/budget/citizen-taxpayer-action/2016/9-2-16-osc-complaint/9-30-16-response.htm>. The September 30, 2016 memorandum of law is important for yet another reason: it furnishes a snapshot of the *modus operandi* of New York's highest law enforcement officer – the State Attorney General – who, when he has NO legitimate defense, corrupts the judicial process with litigation fraud – and is rewarded with fraudulent judicial decisions. Upon information and belief, NO legislative committee has EVER held a hearing on the operations of the Attorney General's office – not the judiciary committees, the codes committees – nor any committee on “crime victims, crime, and corrections” – all of which have the state attorney general within their jurisdiction. Nor have they examined the EVIDENCE of corruption that pervades New York's courts – eviscerating our constitution, statutes – and the most fundamental ethical and adjudicative standards.

As discussed, I have already requested a meeting with Assembly Speaker Heastie. My e-mail request is below. As I was asked to also complete a meeting request form for the Assembly Speaker, attached is the completed form.

Likewise, I have requested meetings with Temporary Senate President Flanagan, with Senate Minority Leader Stewart-Cousins (who also happens to be MY state senator), and with Assembly Minority Leader Kolb. I have additionally put in requests to the Senate and Assembly Judiciary Committees. Attached is the completed form I filled out for Senate Judiciary Committee Chairman Bonacic. As reflected therein – and as I discussed with you – I would be most pleased if Senator Bailey, as a member of the Senate Judiciary Committee, would also attend.

I am available to answer Senator Bailey's questions – and to assist him to the fullest. May he be a leader in his own right – including by assisting those in the highest positions of leadership.
