By letter dated March 25, 2002, you advised us that you would be "responding fully" to our March 21, 2002 document request relating to the Office of Inspector General. By letter dated April 19, 2002, you memorialized that "the only publicly available information responsive" is "contained in the court system's budget and payroll, which are available for inspection upon request" – a statement we find rather hard to believe.

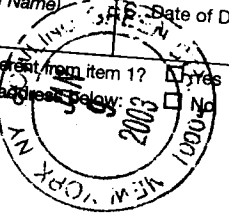
