DECISION & ORDER ON MOTION

In the Matter of Doris L. Sassower,
a suspended attorney.

Grievance Committee for the Ninth
Judicial District, petitioner;
Doris L. Sassower, respondent.

Motion by the respondent for reargument and renewal of this court's order, dated February 24, 1995, which (1) granted the motion by Eli Vigliano, Esq., to withdraw as attorney of record for the respondent. (2) continued the respondent's suspension, pursuant to 22 NYCRR 691.4, for failure to cooperate, with leave to the respondent to move to vacate the suspension after she submits to the court ordered examination, and (3) held the disciplinary proceeding in abeyance pending the respondent's compliance with this court's order of October 18, 1990. Upon the granting of the motion for reargument and renewal, the respondent requests that the court recuse itself from any adjudication of the instant proceedings and transfer the proceedings to another Judicial Department. Upon such recusal and transfer, the respondent seeks vacatur of this court's order of February 24, 1995 and, upon such vacatur, denial of petitioner's motion to confirm the findings of Special Referee Galfunt and to continue the respondent's suspension pursuant to 22 NYCRR 691.13(b)(1). The respondent further seeks vacatur of this court's interim suspension order, dated June 14, 1991, which was continued by this court's order of February 24, 1995, and denial of the motion to withdraw by Eli Vigliano, Esq. as moot and academic. Additionally, the respondent seeks leave to appeal to the Court of Appeals and oral argument of the instant motion.

Upon the papers filed in support of the motion and the papers filed in relation thereto, it is

ORDERED that the motion is denied in its entirety.
