This follows up our phone conversation at noon on Friday, October 6th -- and my refaxing to you of CJA's August 29th transmitting memo entitled "**YOUR ONGOING ELECTION COVERAGE: The Races for New York Governor, U.S. Senator from New York, and New York Attorney General**".

Please advise as to the outcome of your review of the four letters to the candidates which we discussed and which you promised to read. These letters -- ALL posted (with certified mail/rrr, e-mail, & fax receipts) on CJA's website, www.judgewatch.org, accessible via the sidebar panel "Elections 2006: Informing the Voters" -- are:

- (1) CJA's June 20, 2006 memo-letter to the attorney general candidates -- Cuomo & Pirro, among them;
- (2) CJA's September 1, 2006 memo-letter to the attorney general candidates -- Cuomo & Pirro, among them;
- (3) CJA's June 26, 2006 letter to gubernatorial candidate Faso;
- (4) CJA's February 3, 2006 letter to senatorial candidate Spencer.

Do you deny or dispute that these letters lay out FACT-SPECIFIC, DOCUMENTARY EVIDENCE of the corruption in office of Attorney General Spitzer & Senator Clinton -- and additionally reflect upon the unfitness of Mr. Cuomo, Ms. Pirro, Mr. Faso & Mr. Spencer? Will you be directing IMMEDIATE ELECTORAL COVERAGE?
