### TO: Declared Democratic Candidate Terry Gipson

Thank you for offering yourself as a gubernatorial candidate against incumbent Governor Cuomo. You are absolutely right "We the people of the State of New York have the power to take back our government". However, you may not realize that you have the power to make that happen without money – or even party backing. All you need to defeat CUOMO is a scandal -- and this I can furnish you, "on a silver platter".

Cuomo is the first named defendant in a major lawsuit -- a citizen-taxpayer action, brought in the public interest, on behalf of the People of the State of New York, by our non-partisan, non-profit citizens' organization, Center for Judicial Accountability, Inc. (CJA). The lawsuit chronicles Cuomo's corruption and "grand larceny of the public fisc" involving the \$160 billion state budget -- the genesis of which are the fraudulent judicial and district attorney pay raises, which, since April 1, 2012, have stolen from New York taxpayers about \$300 million – to which another \$70 million will be added in the fiscal year beginning April 1, 2018 .

The lawsuit is political dynamite – and, since last August – by the attached August 10, 2017 OPEN LETTER pertaining to your former Senate colleague, the now Westchester County Executive George Latimer – transmitted by the below e-mail – I have been alerting the political parties and would-be candidates of its explosive electoral significance. Quite simply, Governor Cuomo CANNOT be re-elected because he -- and the other defendants to the suit -- Attorney General Schneiderman, Comptroller DiNapoli, and incumbent legislators, Republican and Democratic – must be indicted.
