Did you read the [appeal brief](#) -- & have you seen, from our website, what has been taking place at the Appellate Division, Third Department: <http://www.judgewatch.org/web-pages/searching-nys/budget/citizen-taxpayer-action/2nd/record-app-div.htm> – that the attorney general has NO defense to it?

There is STILL TIME for you, for attorney general lawyer-candidate Sussman, and for gubernatorial candidate Hawkins to turn this election around – and STOP the re-election of corrupt incumbents who must be indicted and will be convicted, as is established, resoundingly, by the EVIDENCE, in your possession – and accessible from CJA's website, including from our webpage for Comptroller DiNapoli: <http://www.judgewatch.org/web-pages/elections/2018/dinapoli.htm>.
