This is to alert you to the GOOD NEWS – which New York's "fake news"/election-rigging, corruption-abetting journalism has been concealing. You can win election easily and without money against Bronx County's re-election-seeking state legislative incumbents – all Democratic. All it requires is using the "bully-pulpit" of your candidacy to whistle-blow about the above-attached FULLY-DOCUMENTED public corruption/grand jury complaint against them, which Democratic Bronx County District Darcel Clark has been "sitting on". The complaint establishes, with EVIDENCE, that they must be indicted on EVIDENCE so *prima facie* and open-and-shut as to assure convictions.

New York's press has known about the complaints for quite some time – and illustrative is the below September 21st e-mail to The New York Times and other New York press, to which Bronx County's 14-re-election-seeking state legislative incumbents – including Carmen Arroyo running on her own "Proven Leader" line -- and D.A. Clark were cc'd so that they could be ready for press inquiries. Individually and collectively, if you stand up for honest, accountable government and make the complaint your campaign issue, you will win – easily. Demand that the complained-against state legislators respond to the complaint, that D.A. Clark explain why she has not presented it to a Bronx grand jury, and that the press do its part to investigate and report.

I am available to answer your questions – and invite you to call. Needless to say, voters are entitled to know from you what salary you expect to be paid, if you were to be elected to the Legislature – and whether you will commit to ensuring: (1) public findings of fact and conclusions of law with respect to the complaint; (2) prosecution of all culpable public officers and their conspirators; and (3) "claw-backs" to recover the approximately half-a-billion dollars in

fraudulent salary increases, already paid out. I specifically ask for responses from non-incumbent Democratic Candidate Amanda Septimo, running against “Proven Leader” incumbent Democrat Arroyo, and from non-incumbent Democratic Candidates Chantel Jackson and Kenneth Burgos, for whom the general election is a mere technicality – each running in non-competitive, open-seat races against Republican and Conservative candidates who have no website or facebook pages.

In that connection, I ask Republican Candidate James Gisondi, to whom I e-mailed the June 8th public corruption/grand jury complaint, on June 14th, after having tracked him down on May 7th, *via* a law directory listing, and Republican Candidate Gene DeFrancis, the sole Bronx Republican or Conservative candidate for whom I was able to track down a posted e-mail address, to forward this e-mail to their 25 fellow Bronx Republican and Conservative candidates whose above-listed names are preceded by an asterisk (*), as none seem to have any campaign website or facebook page or contact information locatable from the internet.

Finally, to Green Party Candidate Carl Lundgren – Bronx’s only Green Party candidate – who concludes his [facebook entry about himself](#) with the sentence “Political revolution is long overdue”, the above attached and below will enable you to achieve a sweeping “political revolution” in this state and beyond. Did you wish to take the lead?
