This is to alert you to GOOD NEWS. You can EASILY win election to the state legislative seats you seek – and without expenditure of money. All it requires is using the “bully-pulpit” of your candidacy to whistle-blow about the above-attached FULLY-DOCUMENTED public corruption/grand jury complaint against Monroe County’s 13 state legislators – most running for re-election against you – which Monroe County District Attorney Doorley has been “sitting on”. The complaint establishes, with EVIDENCE, that the incumbent state legislators must be indicted on EVIDENCE so *prima facie* and open-and-shut as to assure convictions.
