This is to alert you to GOOD NEWS. You can win election easily and without money against Ulster County's re-election-seeking state legislative incumbents. All it requires is using the "bully-pulpit" of your candidacy to whistle-blow about the above-attached FULLY-DOCUMENTED public corruption/grand jury complaint against them, which Ulster County District Attorney Clegg has been "sitting on". The complaint establishes, with EVIDENCE, that they must be indicted on EVIDENCE so *prima facie* and open-and-shut as to assure convictions.
