This is to ALERT YOU TO GOOD NEWS. New York's Republican Party can WIN, easily and with nominal money, every state Senate and Assembly seat in which it is fielding competent challengers to Democratic state legislative incumbents – and The New York Times was well aware of this when it published its back-to-back "fake news" articles: "Can This Billionaire Save N.Y.'s Senate Republicans?" (October 16, 2020, James McKinley) and "N.Y.C. Was Once a Bastion of G.O.P. Moderates. Then Trump Came Along" (October 17, 2020 Dana Rubenstein, Azi Paybarah). Both articles conceal what The Times and New York's other press were alerted to, repeatedly, since July 3rd: that New York's 213 state legislative incumbents -- mostly Democrats and most running for re-election – are the subjects of 62 public corruption/grand jury complaints, whose open-and-shut, prima facie EVIDENCE not only brings ALL of them down – beginning with Democratic Senate Majority Leader Stewart-Cousins and Democratic Assembly Speaker Heastie – but, additionally, the Democrats at the TOP of New York's executive branch -- Governor Cuomo, Lt. Governor Hochul, Attorney General James, Comptroller DiNapoli – and the Democrats at the TOP of its judicial branch: Chief Judge DiFiore and the mostly Democratic six associate judges of the New York Court of Appeals, all appointed by Governor Cuomo.

The succession of e-mails I sent to The Times and other New York press, over the past 3-1/2 months, alerting them to the 62 public corruption/grand jury complaints – and that New York's 62 district attorneys were ALL "sitting on" them – effectively rigging the 213 state legislative races -- are posted on CJA's website, www.judgewidth.org – accessible from the prominent homepage center link: "ELECTIONS 2020 -- Taking Out Corrupt & Collusive Legislative Incumbents & Conspiring D.A.s -- All Beneficiaries of Statutory-Violative, Fraudulent, Unconstitutional Pay Raises & Other Larcenies of Taxpayer Monies". Inasmuch as the above two Times articles both attribute the demise of New York's GOP to President Trump, with the second article focused on Manhattan and stating "There are no Republicans from Manhattan in...the State Legislature", I believe the appropriate starting point for your review is my below September 22nd e-mail to The Times, to which New York City's other press was cc'd. It pertains to the above-attached June 9, 2020 public corruption/grand jury complaint against Manhattan's 18 Democratic state legislators that Democratic Manhattan D.A. Vance is "sitting on". Entitled: "Will The New York Times report on evidence supporting President Trump's claim that Manhattan D.A. Vance's investigation & grand jury proceedings concerning him are 'politically motivated'? How about NYC's other press?", I received no response from The Times – or from the other cc'd press – and their subsequent reporting made their answer further obvious: they would NOT report on EVIDENCE substantiating President Trump's charge that D.A. Vance is "politically-motivated" – of which his "sitting on" the June 9th complaint was – and is -- a PERFECT example.

Disappointingly, I also received no response from President Trump's two lawyers, who I had also cc'd on the e-mail, Jay Sekulow, Esq. and William Consovoy, Esq. – not even confirmation from the latter, to whom I sent a further e-mail,

requesting that he forward my below e-mail to President Trump's other lawyers – most especially Rudolph Giuliani – and that Mr. Giuliani and/or Mr. Sekulow, both of whom had recently appeared on FOX News, forward it to FOX.

I would, therefore, greatly appreciate if you would forward this e-mail – with the below September 22nd e-mail and its three above attachments – to Mr. Giuliani and FOX News. To all, I reiterate what I had stated to Mr. Consovoy, in closing:

“I am available to answer any questions – including as to my interactions with New York's corruption-abetting, election-rigging ‘fake news’ press, spanning more than 30 years – as to which CJA's website, www.judgewatch.org, posts a mountain of EVIDENCE, accessible from the left-side panel ‘Press Suppression’, including a lawsuit against The New York Times, seeking to recognize a cause of action for ‘journalistic fraud’, which should be of particular interest.”

Subject: Will The New York Times report on evidence supporting President Trump's claim that Manhattan D.A. Vance's investigation & grand jury proceedings concerning him are "politically motivated"? How about NYC's other press?

TO: Benjamin Weiser & William Rashbaum/The New York Times

Your yesterday's article "Trump Could Be Investigated for Tax Fraud, D.A. Says for First Time" – printed in today's newspaper – reports that lawyers for President Trump have claimed that Manhattan District Attorney Vance's investigation of the President to support a possible grand jury inquiry is "politically motivated". Will you investigate and report on EVIDENCE **proving** that D.A. Vance has, in fact, flagrantly politicized his office?

Above-attached is that EVIDENCE: the **fully-documented** June 9, 2020 public corruption/grand jury complaint against Manhattan's 18 state legislators – all running for re-election and all Democratic – that Democratic Manhattan D.A. Vance has been "sitting on" for the past 3-1/2 months -- and whose referred-to open-and-shut, prima facie EVIDENCE of larceny and fraud goes right to Democratic Governor Cuomo. Indeed, a companion public corruption/grand jury complaint against Governor Cuomo was filed on June 4, 2020 with re-election-seeking Democratic Albany District Attorney Soares, who has been "sitting on" it – thereby protecting not only Democratic Governor Cuomo, but Democratic Lt. Governor Hochul, Democratic Attorney General James, Democratic Comptroller DiNapoli, all the Legislators, most of them Democratic, and – among the judiciary – the seven judges of the New York Court of Appeals, all appointed by the Governor and mostly Democratic. This replicates what D.A. Soares has done, since 2013, with my four prior fully-documented public corruption complaints against Governor Cuomo, et al. – "sitting on" each and every one of them.

Below, with the above three attachments, is my yesterday's e-mail to The Times and other New York City press requesting investigative reporting about the June 9, 2020 complaint that D.A. Vance has been "sitting on" – to which I cc'd D.A. Vance so that he could be ready for press inquiries. For the same reason, I cc'd D.A. Vance on my prior September 8, 2020 e-mail to The Times. The webpage on which that prior e-mail is posted, with my essentially-identical September 8, 2020 e-mails to other New York City press on the same topic, is here.

As President Trump's lawyers plainly have an interest in EVIDENCE that substantiates the political motivation they have ascribed to D.A. Vance, I am cc'ing the two whose names have appeared in your reporting – Jay Sekulow, Esq. and William Consovoy, Esq. I will separately contact FOX News so that – in the absence of reporting by The Times and other New York City press, also here cc'd – it can report on the mountain of public corruption detailed by the June 9, 2020 complaint, ALL of which The Times and other press have knowingly concealed, for years, in their "fake news", election-rigging reporting and editorializing – perpetuating the swamp that is New York's governance, which they are continuing to do.

Now, for the third time, I am cc'ing D.A. Vance, so that he can ready himself accordingly.

As you know, Manhattan's 18 state legislators – ALL running for re-election, including Senate Finance Committee Chair Liz Krueger, Senate Judiciary Committee Chair Brad Hoylman, Senate Committee on Budget and Revenues Chair Brian Benjamin, and Administrative Regulations Review Commission Assembly Chair Dan Quart – are the subjects of a **fully-documented** public corruption/grand jury complaint, filed with Manhattan District Attorney Vance, who has been "sitting on" it. The complaint involves the "force of law" commission/committee scheme that gave all the legislators pay raises – and a legislature not operating at a remotely constitutional level.

The June 9, 2020 complaint, by the Center for Judicial Accountability, Inc. (CJA), is above-attached – and below are the e-mails transmitting it and the above-attached July 29, 2020 FOIL request to D.A. Vance. CJA's substantiating evidentiary webpage for the complaint is here: <http://www.judgewatch.org/web-pages/searching-nys/2020-legislative/grand-juries.htm>.

As stated by the complaint, Manhattan voters are entitled to know that **their state legislators cannot be re-elected because they must be indicted for larceny and other corruption on EVIDENCE so DISPOSITIVE as to assure their convictions.**

To facilitate your inquiries of the complained-against state legislators and D.A. Vance, I am cc'ing them on this e-mail. What, if anything, do they deny or dispute. Let them start where the complaint starts: my July 16, 2019 e-mail to Senate Finance Committee Chair Krueger and the Legislature's 14 other stipend-receiving leaders requesting that they forward the e-mail to the 198 other state legislators, with its attached July 15, 2019 written NOTICE and substantiating analysis establishing that the December 10, 2018 Report of the Committee on Legislative and Executive Compensation – raising their legislative salaries from \$79,500 to \$110,000 – is "a fraud on the People of the State of New York – and a larceny of their tax dollars', violating a succession of penal laws, and that their duty was to void it, to return the pay-raise monies they had already received, and to initiate criminal prosecutions of the Committee's four members and abetting attorneys." The analysis is 46 pages, excluding exhibits. Will they furnish you with their findings of fact and conclusions of law? If not, I'm sure ordinary Manhattan citizens would be able to help you with what is obvious. Just accompany your story with links to the complaint and the evidentiary webpage so that they can see for themselves the open-and-shut, *prima facie* EVIDENCE that D.A. Vance has been withholding from a Manhattan grand jury.

I am available to answer your questions and assist you, to the max -- on a story not only upending each and every one of Manhattan's 14 state legislative races, but, additionally, ALL New York's other state legislative races and its 15 D.A. races – and **that's for starters**.
