### TO: Fulton County Libertarian Chair Brandon Lyon

Responding to your below e-mail, thank you for your concern about “a leadership vacuum in the state party”. I am pleased to report that yesterday afternoon I received a call from State Party Chair D’Orazio and we had a lengthy and productive conversation pertaining to my yesterday morning’s e-mail which had elicited Niagara County Libertarian Chair Charlie Flynn’s response – and then your own, later in the day.

Prior thereto, Charlie had also called me – and I also had a call from State Committee Member Mark Glogowski, who is the Libertarian Party’s candidate for the 139<sup>th</sup> Assembly district seat. State Committee Member Jim Harris also reached out to me, by e-mail, with a helpful suggestion, and there was, additionally, an e-mail from Genesee County Chair Mark Potwora. I take this opportunity to thank them all.

There is much we can do, working together, to enable the Libertarian Party to meet its leadership potential – easily and without significant cost. Indeed, based on my above attached March 18, 2020 letter, the Libertarian Party can more than WIN – on an immediate motion for summary judgment -- the lawsuit proposed by my April 20<sup>th</sup> e-mail. I believe it can also recover its counsel fee/costs AND, additionally, sue for, and obtain, significant PUNITIVE damages. I discussed this with Chair D’Orazio – and the need to solicit expert opinion, such as from Libertarian Party attorney James Ostrowski and other lawyer-Libertarian Party members who can assist in the evaluation.

Please call me, at your earliest convenience, so that we can discuss the 2020 elections for Fulton County state legislative seats and for district attorney. I have created a webpage for the Fulton County 2020 races – and the important role of



third party chairs, like yourself. It is accessible from CJA's homepage, [www.judgewatch.org](http://www.judgewatch.org), via the prominent first center link: "ELECTIONS 2020 – Taking Out the Corrupt & Collusive Legislative Incumbents – *All Beneficiaries of Statutory-Violative, Fraudulent, Unconstitutional Pay Raises & Other Larcenies of Taxpayer Monies*". The menu page it brings up includes a link entitled "THE IMPORTANT ROLE OF THIRD PARTY COUNTY CHAIRS" – and it will lead you to the Fulton County webpage.
