As will swiftly be obvious to you, AG James cannot be re-elected, because she must be indicted – and will be convicted, as likewise the many other public officers for whom she has corrupted her office and

who are running in this year's races – Governor Hochul, Comptroller DiNapoli – and New York's state legislators, among them.
