A short time ago, I heard you on Tucker Carlson, speaking about New York Attorney General James' lawsuit against former President Trump, his children, and the Trump Organization, which she announced at a press conference earlier today. By way of

correction, although I see from other reporting where you got your info that AG James is "trailing" in her race for re-election, I do not believe that to be remotely true. Her AG challenger, Michael Henry, Esq., running on both Republican and Conservative lines, is an uncredentialled, nothing candidate, put up for show and not waging any kind of serious race. The July 22, 2022 e-mail I sent him, entitled "You can easily win, & without \$, vs AG James, as she is corrupt & must be indicted & will be convicted, based on EVIDENCE...", to which I received no response, is here.

I am director and co-founder of the NY-based non-partisan, non-profit citizens' organization Center for Judicial Accountability, Inc. (CJA) – and have direct, first-hand experience with NY Attorney General Letitia James and how her AG's office operates. She and the office are corrupt and politicized – and I have laid this out in FULLY-DOCUMENTED complaints against her for corruption involving larceny of massive amounts of taxpayer monies *via* a "slush-fund", completely "off-the constitutional-rails" NYS budget and fraudulent pay raises of which she is a beneficiary. These have been filed with the FBI, NY's 4 US Attorneys, 62 District Attorneys – and such ethics authorities as NY's attorney grievance committees and the former Joint Commission on Public Ethics (JCOPE), which is now the Commission on Ethics & Lobbying in Government (CELG).

Last year, I tried to reach Mr. Trump – creating a webpage with a June 4, 2021 "Dear Mr. Trump" message for him, highlighting AG James' hypocrisy in going after him on the pretense that "no one is above the law", when she herself is TOTALLY "above the law" – "protected" by all these criminal and ethics authorities – and the press – from ANY accountability. The direct link to the "Dear Mr. Trump" webpage is <a href="here">here</a> — and the first link, at the top, is to a separate webpage with the complaints I have filed against AG James – featuring my February 11, 2021 attorney misconduct complaint against her, mandating that she be disbarred and referred to criminal authorities for indictment. For your convenience, here's the <a href="EVIDENTIARY webpage">EVIDENTIARY webpage</a> for the February 11, 2021 complaint — which, because AG James is registered in NY's First Judicial Department, is within the jurisdiction of the First Department Attorney Grievance Committee.

My most recent complaint vs AG James was on July 8, 2022 to CELG – and was its first. It pertains to her litigation fraud to defeat CJA's major lawsuit vs her and NY's other highest constitutional officers for corrupting ethics/public protection oversight over themselves – and pertains to the state budget and pay raises. The September 15, 2022 notice of motion that I filed against AG James to sanction her, to refer her to disciplinary and criminal authorities, and for her disqualification is <a href="##493">#93</a>.
