### **SPREAD THE WORD – Mamdani's Win as NYC Mayor is being Rigged by the NYT & Other NY Press, Concealing his Corruption as a NYS Assemblyman – A Scandal He Cannot Survive**

Zohran Mamdani's win as NYC mayor is being rigged by The New York Times and other NY press. In tandem with their pervasive anti-Israel slanting and defamations, giving credibility and resonance to Mamdani's anti-Israel, pro-Hamas falsehoods, they are concealing his corruption as a NYS assemblyman.

This corruption, destroying lawful, constitutional, state governance and irreparably injuring the People of New York, involves the NYS budget, Mamdani's legislative salary, and NY's oversight/"public protection" entities – proven by open-and-shut, *prima facie* EVIDENCE.

Long before the June 24<sup>th</sup> NYC Democratic mayoral primary, The Times and other NY press had this EVIDENCE, but reported nothing. And they have reported nothing about it since. This, with knowledge that it is dispositive that Mamdani is unfit for any office of public trust and that he must be indicted – and will be convicted – of willfully violating a succession of NY penal laws.

The catastrophic result of this concealment by The Times and other NY press of what NYC voters most need to know and their incessant reporting of polls, endorsements, and fundraising that their own fraudulent, "fake news", fawning journalism generates is that NY's Jewish, pro-Israel, and other communities are dispirited and have been inhibited from mobilizing against Mamdani because of the purported inevitability of his electoral victory in November.

Yet, **Mamdani can EASILY be taken out – and without expense – by the "free press" simply doing its job of reporting on the EVIDENCE of his corruption as a NYS assemblyman.** What's more, this same EVIDENCE clears the field of mayoral contenders Cuomo, Adams, Sliwa, and Walden – and upends NYC's other TOP races for NYC public advocate, for Manhattan borough president, for Manhattan D.A., and for Brooklyn D.A., also being rigged by The Times and other NY press.
