Gentlemen:

- 1a. Did IRA POSTEL, Esq., produce the documents legally demanded in my Notice of Cross-Motion, dated September 23, 1986? -- Of course not!
- b. The <u>on the record</u> and <u>affidavit</u> representations of IRA POSTEL, Esq., to Mr. Justice THEODORE DACHENHAUSEN, JR., were deliberately falsely uttered, perjurious, and contrived, and made to criminally deceive (<u>Judiciary Law</u> §487).
- 2a. These corrupt, in-bed, incestuous, <u>ex parte</u> arrangements and agreements made with the corrupt Mr. Justice IRA GAMMERMAN, are brazenly made without notice, without any pre-text of due process, and with false recitation clauses, and representations!
- b. There was simply no notice, nor any papers, with respect to the contempt proceedings leading to the Contempt Order of March 11, 1986 (cf. <u>Judiciary Law</u> § 756), the contrived statements contained in same to the contrary notwithstanding!
- c. There simply was no notice, nor any papers, with respect to the proceedings of June 16, 1986, the perjurious statements of Mr. Postel to the contrary notwithstanding!
- d. Only by some demented reasoning of Mr. Postel, I am faulted for not being present at the proceedings of June 16, 1986, when the first notice of same was by a contempt proceeding thereafter served, making unlawful what was absolutely lawful when performed!

3a. The "Manton mark" on the "corruption scale" has long been passed, since Chief Judge Martin T. Manton did not put District Thomas E. Dewey in jail for exposing his corrupt activities!

b. Mr. Justice IRA GAMMERMAN, in addition to being corrupt, is the judge who had the gall to prohibit me from communicating with the Grievance Committee or any Professional Disciplinary body with respect to the activities of his criminal patrons, "the felons with law degrees", and their co-conspirators, which includes IRA POSTEL, Esq.

4a. These legal lepers will continue their criminal and unethical activities as long as they are confident that you will do nothing about it!

b. You must understand that I and another were incarcerated because of such corruptly secured Gammerman Orders, and I intend to stop at nothing to expose their true nature!
