BILL NUMBER: A3001A

SPONSOR: Budget

TITLE OF BILL: An act making appropriations for the support of government

(LEGISLATURE AND JUDICIARY BUDGET)

SUMMARY: This bill would enact appropriations in support of the Legislature and Judiciary for State Fiscal Year (SFY) 2015-16, and includes an All Funds appropriation of \$3.015 billion.

JUSTIFICATION: Enactment of this legislation is necessary to provide for the operations of the Assembly, Senate and the Unified Court System throughout SFY 2015-16.

FISCAL IMPACT: This bill authorizes disbursements of up to \$2.754 billion from the General Fund and up to \$3.002 billion on an All Funds basis.

EFFECTIVE DATE: Effective immediately, and the appropriations contained in this bill shall be made for the fiscal year beginning April 1, 2015.
