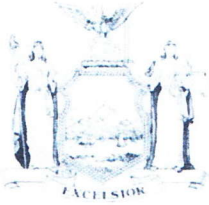
Attached is corrected letter, correcting the third paragraph:

To accommodate the addition of further record references and possible additional text, appellants request to be permitted to submit a reply brief of no more than 6,000 words in excess, *to wit*, a maximum of 13,000 words.
