Thank you for your email of 1:16 p.m. I want to make sure you received my earlier email of 12:15 p.m. with comments on the proposed record. (Another copy is attached for convenience.) The record found at your link does not have a stipulation at the end. I do not think the Appellate Division will accept your record without a stipulation. As indicated in my email, the record requires a few corrections.
