Following up our phone conversation this morning – for which I thank you -- the [Committee on Standards and Ethics](#) that Council Member Yeger chairs – and which “has jurisdiction over New York City’s Conflicts of Interest Board” – must discharge oversight over the Conflicts of Interest Board, as it is corrupt – flagrantly violating conflicts of interest rules and protocols with regard to FULLY-DOCUMENTED complaints filed with it, involving and implicating those with whom its members and staff have professional and personal relationships.

The same is true of the New York City Department of Investigation with which the Conflicts of Interest Board is partnered – and jurisdiction over it belongs to the [Committee on Oversight and Investigations](#), chaired by [Council Member Brewer](#), of which Council Member Yeger is a member.

The corruption of these two vital NYC public integrity entities – the product of their flagrant violation of conflicts-of-interest rules – is evidenced by the record of the [May 17, 2021 conflict-of-interest/corruption complaint](#) I filed with both of them against New York City Public Advocate Jumaane Williams and New York City’s five district attorneys. As I showed you, the record is accessible from CJA’s website, www.judgewatch.org, via the left side panel “Searching for Champions-NYS”. The direct link to the combined webpage for the “New York City Department of Investigation & Conflicts of Interest Board”, posting the record of my May 17, 2021 complaint and of my [June 28, 2021 complaint based thereon](#) against the Conflicts of Interest Board and Department of Investigation and filed with them is here: <https://www.judgewatch.org/web-pages/searching-nys/district-attorneys/NYC/nyc-doi-coib.htm>.

In addition to the Committee on Standards and Ethics and the Committee on Oversight and Investigations, I believe the [Committee on Governmental Operations](#) also has a role to play – and especially with regard to the corruption and politicization of the Office of Public Advocate under Jumaane Williams, presented by my May 17, 2021 complaint. [Council Member Ung](#) chairs that Committee, of which Council Member Brewer is a member.

Please confirm that this e-mail is sufficient for initiating investigation and oversight by the Committee on Standards and Ethics. I am available to answer questions and to appear before the Committee, including under oath.

Finally, below is my August 10th e-mail to you, which you had asked me to send again, as it had not reached you because I had made an error in your e-mail address. I'm glad we could figure out the mystery of what had happened to it.
