Dear County Attorney Reichenbach,

Thank you for your response – and I have no problem making distribution of the letter by other means.

At present, I am revising the letter for purposes of clarity and because of size restrictions precluding my attaching the underlying letters to e-mail. The revised, superseding letter, to bear today's date, will be completed shortly.

At issue is not “political discretion”, but evidentiary proof that the August 29, 2011 and December 24, 2015 reports on which the salary increases rest are “false instruments” and violate a succession of penal law provisions.

Kindly, take the opportunity to examine the documentary evidence, identified at p. 4 of the underlying June 29, 2016 letter to DAASNY's president. What are Warren County District Attorney Hogan's findings of fact and conclusions of law with respect to that evidence? What are yours?

The huge stack of documents beside me (which I furnished to the Commission) is, almost entirely the evidence identified at page 4 of the June 29, 2016 letter as establishing the fraudulence and unlawfulness of the August 29, 2011 report of the Commission on Judicial Compensation – and which I stated was “open and shut” and could be determined “within minutes”.
