Following up our phone conversation, bravo to Lewis County legislators for rejecting the district attorney salary increase at their August 2nd meeting, reported in the Watertown Daily Times the following day. It appears, however, that the legislators were unaware of the Center for Judicial Accountability's July 8th letter to them – which I had e-mailed to Lewis County Attorney McNichol, with a request that she furnish it to “all Lewis County legislators, executive officers & the treasurer/comptroller”.

Below is a copy of my July 12th transmitting e-mail to County Attorney McNichol, a copy of which I simultaneously sent to Lewis County District Attorney Moser.

TO: Lewis County Attorney Joan McNichol –

Kindly supersede the July 8, 2016 letter I previously sent you with the attached revised letter – and furnish to all Lewis County legislators, executive officers & the treasurer/comptroller. Unless I hear from you to the contrary, I will assume you have done so.

To assist Lewis County in taking protective steps, I am directly sending this e-mail to Lewis County District Attorney Moser so as to further reinforce her duty to promptly furnish you and Lewis County's other public officers with her findings of fact and conclusions of law with respect to the citizen-taxpayer action, *Center for Judicial Accountability, Inc. v. Cuomo, et al.* (Albany Co. #1788-2014). Does she deny or dispute its rock-solid evidentiary showing that the judicial salary increases, on which her own district attorney salary increases rest, are statutorily-violative, fraudulent -- & unconstitutional? How about our June 21, 2016 corruption complaint filed with Albany County District Attorney Soares? Does she deny or dispute its sufficiency for founding criminal indictments for violations of the penal law – and convictions?
