NOW THEREFORE; in consideration of the mutual covenants contained herein and in accordance with the terms and conditions hereinafter stated, it is mutually agreed as follows:

- 1. Except as hereinafter provided, the parties hereby ratify, confirm and continue in all particulars the agreement entered into on December 15, 2018 and amended on December 14, 2019.
- 2. The not-to-exceed amount of compensation for services rendered shall be amended and increased from Two Hundred Fifty Thousand dollars (\$250,000.00) to Three Hundred Thousand dollars ✓ (\$300,000.00). The original amount of Five Thousand dollars (\$5,000.00) set for aside reasonable travel expenses remains the same.

- 3. The term of C111971 is hereby extended and renewed for the period of December 15, 2020 and \checkmark ending on December 14, 2021.
- 4. The parties hereby agree, except as hereinafter provided, this amendment incorporates and extends all terms and conditions set forth in Contract Number C111971.

The Assembly wishes to renew contract C111971 with the law office of Orrick, Herrington, & Sutcliffe for the continued the representation of the New York State Assembly in the Matter of Roxanne Delgado et al. v. The State of New York et al., Index Number 907537-18. The OAG declined to represent the Assembly in this matter, the Assembly appeared in this action as an Amici, friend of the court, and the OAG cited a conflict of interest. The lawsuit was initiated to challenge the decision of the NYS pay commission to increase the salaries of New York State Legislators over a three year period. Currently, the matter is before the New York Court of Appeals, where the Assembly is an Amici. As a result, the Assembly wishes to renew the contract for an additional year, to expire December 14, 2021. Additionally, the Assembly seeks to amend and increase the total not-to-exceed amount for services rendered.

The law office of Orrick, Herrington, & Sutcliffe LLP has continued to provide exceptional work and advocacy on behalf of the Assembly. The initial non-to-exceed amount under this contract was \$250,000.00, and currently there is approximately \$24,830.00 remaining. The not-to-exceed amount is amended and increased to \$300,000.00. The amount set aside for reasonable travel expenses remains the same.

Additionally, the fee schedule will continue to remain a blended rate of \$550.00 per hour for the work of Attorneys and a rate of \$250.00 per hour for the work of paralegals.
