- all records pertaining to the proposal of LEC's current January 3, 2022 Bylaws, such as when they were proposed, by whom, for what reason – and reflecting the changes it would make to the September 24, 2012 Bylaws;
- all records of the LEC meeting(s) at which the current January 3, 2022 Bylaws were on the agenda for discussion and vote, including notices of those meetings to LEC members;
- a copy of the minutes of LEC's January 3, 2022 meeting at which the current Bylaws were adopted, presumably including the names of the LEC members present and voting (see new Bylaw Article II "Meetings": §7, §8; and new Bylaw Article VI "Adoption and Amendment of Bylaws".
