Thank you, Josalyn, for the generous amount of time you gave to our call together. I will greatly look forward to reviewing the legislative salary information you send and, more importantly, the <u>legislative compensation</u> information. As discussed, the 2018 report of the Committee on Legislative and Executive <u>Compensation</u>, like the 2015 report of the Commission on Legislative, Judicial, and Executive <u>Compensation</u>, like the 2011 report of the Commission on Judicial <u>Compensation</u>, ALL violated the statutes pursuant to which they purported to be rendered by NOT examining, <u>at all</u>, "compensation and non-salary benefits", as they were required to do. The only thing they examined, and in the most superficial, sham fashion, was salary.

EVIDENCE of what has been going on regarding salary, divorced from compensation — the highlights of which I tried to summarize for you. Here's the link from the homepage center panel entitled:

It brings up a menu of options — and you'll want to examine, as a priority, the 2018 Committee on Legislative and Executive Compensation — as its December 10, 2018 report is how NYS legislators were able to get a salary jump, on January 1, 2019, from \$79,500 to \$110,000. From there, you can jump to the July 15, 2019 analysis I did of the Committee's December 10, 2018 report, which I furnished to the Legislature, Governor, Attorney General, accompanied by a NOTICE of their duty to take correction action.
