I am director and co-founder of the non-partisan, non-profit citizens' organization [Center for Judicial Accountability, Inc.](#) (CJA)

Your Staff Counsel Glenn Simpson and your Chief Counsel Courtney Osterling have corrupted their offices – and are the subject of a complaint to you that I embodied in the above-attached March 26, 2024 request for full Committee reconsideration that I sent to [ad2-grv9@nycourts.gov](mailto:ad2-grv9@nycourts.gov) by the below e-mail. Was it furnished to you?

According to Staff Counsel Simpson's [February 26, 2024 letter](#), my fully-documented January 29, 2024 complaint against an attorney member of the Commission on Legislative, Judicial and Executive Compensation, whose December 4, 2023 misnomered "Report on Judicial Compensation" is a "false instrument" – so-proven by my [January 18, 2024 Opposition Report](#) substantiating the complaint – "does not state a complaint of professional misconduct".

In pertinent part, my rebutting March 26, 2024 letter states (at p. 4):

"Penal Law §175.35: 'Offering a false instrument for filing in the first degree' is a long-recognized ground for disbarment, [In re Chu](#), 42 NY2d 490 (1977), utilized by this Committee to procure automatic disbarment for analogous federal charges. As illustrative of Appellate Division, Second Department's decisions granting this Committee's motion to disbar on that ground:

- *In re Posner*, 60 AD2d 149 (1977);
- *In re Krup*, 136 AD2d 351 (1988);
- *In re Connery*, 157 AD2d 12 (1990);

- [Matter of Levine](#), 7 AD3d 4 (2004);
- [Matter of Evans](#), 58 AD3d 164 (2008);
- [Matter of Shepherd](#), 66AD3d 14 (2008);
- [Matter of Griffiths](#), 116 AD3d 117 (2014)”.

CJA’s webpage for the January 29, 2024 complaint – one of three against three attorney-members of the Commission on Legislative, Judicial and Executive Compensation that I simultaneously filed with the three Appellate Division, Second Department attorney grievance committees – and the correspondence thereon is [here](#).

Kindly forward this e-mail to the AD2-AGC9 members whose e-mail addresses I do not have, *to wit*, the three non-lawyer members and lawyer-member Robert A. Weis, whose law office declined to provide same. As for lawyer-member Dennis E. Glazer, who is the husband of former Chief Judge Janet DiFiore, I leave it to your discretion as to when this e-mail should be forwarded to him, inasmuch as the Opposition Report focally rests on the citizen-taxpayer action [CJA v. Cuomo...DiFiore](#), about which I testified, with the entire file, before the Commission at its October 13, 2023 public hearing ([VIDEO, at 2hrs/31 mins](#); [Tr. pp. 101-108](#)).

I am available to answer questions and would welcome the opportunity to do so, under oath, to you – and to Unified Court System Inspector General Porter Campbell, cc’d on the March 26, 2024 letter.
