- Legislative Commission on Governmental Administration, whose homepage, <a href="https://nyassembly.gov/comm/?id=49">https://nyassembly.gov/comm/?id=49</a>, reflects three members: its Assembly Chair, Diana Richardson, and Assembly members Karl Brabenic and David DiPietro;
- 3. Legislative Commission on Legislative Ethics, whose homepage, <a href="https://nyassembly.gov/comm/?id=48">https://nyassembly.gov/comm/?id=48</a>, reflects a single member: its Assembly chair, Jo Anne Simon;
- Legislative Commission on Rural Resources, whose homepage, <a href="https://nyassembly.gov/comm/?id=47">https://nyassembly.gov/comm/?id=47</a>, reflects four members: its Assembly chair, Angelo Santabarbara, and Assembly members Philip Palmesano, Mark Walczyk, and Carrie Woerner;

- the Legislative Commission on Rural Resources, whose homepage:

Additionally, the Legislative Task Force on Demographic Research and Reapportionment is not accessible from the Senate's webpage for "Senators & Committees" — and when the previously posted link is utilized: <a href="https://www.nysenate.gov/committees/task-force-demographic-research-and-reapportionment">https://www.nysenate.gov/committees/task-force-demographic-research-and-reapportionment</a>, the Task Force comes up "INACTIVE", with no members. As for the Assembly's webpage for the Legislative Task Force on Demographic Research and Reapportionment, <a href="https://nyassembly.gov/comm/?id=60">https://nyassembly.gov/comm/?id=60</a>, accessible from its webpage for "Committees and More", it reflects a single member, its Assembly chair Robert Rodriguez.
