The Senate Judiciary Committee's webpage, <a href="https://www.nysenate.gov/committees/judiciary">https://www.nysenate.gov/committees/judiciary</a>, features the Committee's 2017 Annual Report. Scrolling through the Committee's "News" and "All Updates" tabs, the 2017 Annual Report was posted on January 24, 2018, simultaneous with the Committee's posting of its 2016 Annual Report.
