TO: Westchester County District Attorney Miriam Rocah

This follows media reports of [your August 4, 2021 letter to Attorney General James](#) requesting -- based on her [August 3, 2021 report](#) by "independent investigators" into "allegations of sexual harassment and misconduct by Governor Andrew M. Cuomo" -- that she furnish you with the underlying evidentiary materials pertaining to acts committed in Westchester County so that you can determine whether they might support crimes by the Governor for you to prosecute.

This request was apparently *sua sponte* on your part.

By contrast, it is now more than 6-1/2 months since I filed with you my above-attached January 19, 2021 complaint, by my below January 19, 2021 e-mail, then sent again by my below February 12, 2021 e-mail, furnishing you with the *prima facie*, open-and-shut, EVIDENCE of a slew of crimes committed and being committed, *inter alia*, by Westchester County's state legislators, involving Governor Cuomo and Attorney General James, pertaining to pay raises, of which they and you are beneficiaries, and the budgets of both New York State and Westchester County. To this, I have received no response.

Is it your view that any potential crime by Governor Cuomo arising from his so-called "sexual harassment" of women with whom he flirted -- as to which you had no filed complaint -- "holds a candle" to the ACTUAL crimes he committed, in tandem with a large swath of Westchester County public officers, past and present, pertaining to fraudulent pay raises and the budgets of Westchester County and New York State -- evidentially-established by the FULLY-DOCUMENTED January 19, 2021 complaint I signed under penalties of §210.45 of the Penal Law.

Please advise and -- if you are not recusing yourself for conflicts of interest and activating appropriate protocols for appointment of a special prosecutor -- confirm that you will be scheduling me to testify before a Westchester County grand jury in support of my January 19, 2021 grand jury/public corruption complaint, so that it can perform its function under Article I, §6 of the New York State Constitution and Criminal Procedure Law Article 190.

By the way, am I correct in assuming, based on the Attorney General's August 3rd report and your August 4th letter, that Governor's Cuomo's potential Westchester County "sexual harassment" crimes that you have *sua sponte* chosen to investigate would, at most, be simple misdemeanors not requiring grand jury indictment?

Finally, inasmuch as I have also received no response from your FOIL office to my January 19, 2021 e-mail, which I sent to it then and again on February 12, 2021, I am cc'ing the FOIL office on this e-mail.

Subject: Public corruption/grand jury complaint vs Westchester County state legislators & other public officers for "wilful misconduct in office" including fraud and larceny pertaining to their own salary raises & the state & county budgets -- plus FOIL request

TO: Westchester County District Attorney Miriam Rocah

Above attached is your completed complaint form – and the two public corruption complaints on which it rests that I filed with your Westchester County D.A. predecessor, Anthony Scarpino, involving the Westchester D.A. salary and the Westchester county budget. These are the same two public corruption complaints about which I gave you notice by the below June 16, 2020 and August 7, 2020 e-mails when you were running to be elected Westchester County D.A. -- to which I received NO response from you.

The only change in the status of these two complaints is that three days after your November 3, 2020 election, D.A. Scarpino sent me a November 6, 2020 letter stating, with respect to the June 10, 2020 complaint against "Westchester County State Legislators":

“Based on the information provided, we have determined that there is insufficient basis for a criminal investigation.”

Such determination is a flagrant LIE by D.A. Scarpino, whose duty it was to have disclosed his financial and other conflicts of interests and to have taken steps to secure appointment of a special prosecutor. This is obvious from the June 10, 2020 complaint, which, in addition to highlighting the threshold issue of D.A. Scarpino’s disqualification, furnished the *prima facie*, open-and-shut EVIDENCE, via a [substantiating webpage](#), from which ANY grand jury would have been compelled to indict the complained-against Westchester state legislators -- starting with the most powerful: Temporary Senate President Andrea Stewart-Cousins -- in discharge of its duty pursuant to Article I, §6 of the New York State Constitution “to inquire into the wilful misconduct in office of public officers and to find indictments”. Likewise obvious is that ANY “criminal investigation” would have compelled indictments of New York’s Chief Judge, the former Westchester D.A. Janet DiFiore – a Westchester resident –and, as explicit from the January 8, 2018 complaint, with its [substantiating webpage](#), indictments of Westchester County’s most consequential public officers: County Executive George Latimer, the County Board of Legislators, and D.A. Scarpino.

Now that you are D.A., you too will be guilty of “wilful misconduct in office” if you repeat what you did as a candidate: ignore, without response, the FULLY-DOCUMENTED January 8, 2018 and June 10, 2020 public corruption/grand jury complaints and your financial and other conflicts of interest arising therefrom. As to those conflicts, they have all been exacerbated since my June 16, 2020 and August 7, 2020 e-mails to you. You are plainly drawing a salary – and, presumably, it is not \$136,700, but the \$210,000-plus resulting from the two commission reports that are each “false instruments”, about which my e-mails alerted you. As for the conflicts arising from the corruption and collusion of several of your endorsers -- your former boss, then U.S. Attorney Preet Bharara, and Berit Berger, then Executive Director of Columbia University’s Center for the Advancement of Public Integrity – you chose, in face of my two e-mails alerting you to their corrupt, collusive conduct, to have Mr. Bharara administer your oath of office and to make Ms. Berger your chief ethics officer.

As previously, I am available to assist you to the max so that you can make good on the anti-corruption, transparency, and accountability rhetoric on which you campaigned in your quest to be D.A. and which you have continued to trumpet. To that end, I have created a webpage for this complaint, from which ALL its substantiating open-and-shut, *prima facie* EVIDENCE is accessible, [here](#). This includes the open-and-shut, *prima facie* EVIDENCE from which ANY grand jury would indict Mr. Bharara and Ms. Berger, speedily. It also includes D.A. Scarpino’s September 24, 2020 response to the above-attached July 28, 2020 FOIL request – which I hereby re-file with you for your own response.

As the injury caused to the People of Westchester County – and New York State – by the systemic governmental corruption laid out by the January 8, 2018 and June 10, 2020 complaints is on-going and irreparable, time is of the essence. Will you – or will you not – be upholding the grand jury’s constitutionally-guaranteed “power...to inquire into” them?

Scarpino Accountable" has now been renamed: "Testing the Fitness of Presumptive Westchester County D.A. What is your response to the two public corruption complaints there posted – as to which my June 16th message asked:

"Will you – as a candidate – 'blow the whistle' about the January 8, 2018 corruption complaint that D.A. Scarpino has been 'sitting on' – and speak out about how he should be handling the June 10, 2020 corruption/grand jury complaint, pursuant to Article I, §6 of the New York State Constitution? And, if not, is it because you suffer conflicts of interests with respect to these complaints – exposing, as they do, the public corruption of several of your endorsers, as, for instance, State Senator Alessandra Biaggi and your former boss, U.S. Attorney Preet Bharara – and the nonfeasance of such endorsers as Berit Berger, Executive Director of the so-called Center for the Advancement of Public Integrity.

If elected, how will you address your financial and other conflicts of interest with respect to each of these two complaints, if action has not been taken by D.A. Scarpino before then."

Please furnish your answers by next Friday, August 14th – and be sure to specify what salary you would expect Westchester County taxpayers to pay you, should you be elected. Is it \$136,700 or \$210,900?

I am director and co-founder of the non-partisan, non-profit citizens' organization, Center for Judicial Accountability, Inc. (CJA), based in White Plains.

Are you aware that the Westchester district attorney's salary comes out of the Westchester County budget – and that the increases in that salary, from the \$136,700 it was prior to April 1, 2012 to the more than \$210,000 it is today, are the

product of two “force of law” commission reports which are “false instruments”, violative of Penal Law §175.35. On January 8, 2018, I filed a fully-documented corruption complaint with Westchester D.A. Scarpino pertaining to his larcenous district attorney salary, seeking corrective action, including prosecution of the Westchester County public officers responsible and complicit. Among these, Westchester County’s 14 state Senate and Assembly members – and D.A. Scarpino. To date, more than 2-1/2 years later, D.A. Scarpino has been “sitting on” the complaint, while financially benefiting from the fraudulent salary increases that Westchester County taxpayers pay for.

Last week, I filed a second corruption complaint with D.A. Scarpino, related to the first. This June 10, 2020 complaint, also fully documented, is solely against Westchester County’s 14 state legislators and seeks a grand jury inquiry and indictments pursuant to Article I, §6 of the New York State Constitution for their “wilful misconduct in office”, including fraud and larceny with respect to their OWN legislative salaries & the Legislature’s OWN budget.” It furnishes proof that the “force of law” committee report that boosted their salaries from \$79,500 to \$110,000 is a “false instrument”, violative of Law §175.35 in virtually identical respects as the two “force of law” commission reports that boosted D.A. Scarpino’s salary.

Both complaints are posted on CJA’s website, www.judgwatch.org, accessible via the prominent center link: “ELECTIONS 2020 – Taking Out Corrupt & Collusive Legislative Incumbents & Conspiring D.A.s – All Beneficiaries of Statutory-Violative, Fraudulent, Unconstitutional Pay Raises & Other Larcenies of Taxpayer Monies”.
