- (3)) the membership dues/fees that Chautauqua County paid each year, from 2016-2020, for its membership in (a) New York State Association of Counties (NYSAC); (b) County Attorneys Association of the State of New York (CAASNY); (c) District Attorneys Association of the State of New York (DAASNY); (d) local and state bar associations.
