Upon discovering a substantive error in my August 31st ethics complaint to JCOPE that I sent you early this morning by the below e-mail, I sent JCOPE – and the SUNY Board of Trustees – a superseding complaint, stating, in the transmitting e-mail:

"The complaint I sent you on August 31st ... stated (at p. 13) that Trustee Hoyte – the Student Assembly President – had voted in support of Mr. Malatras' appointment as chancellor. This is incorrect. In voting, Trustee Hoyte abstained – although his remarks during the meeting were indistinguishable from a vote in support by his only passing reference to 'our process of appointing a new chancellor is a little flawed'.

Above is a superseding complaint, corrected to reflect (at p. 13) that Trustee Hoyte's vote was 'to abstain, rather than oppose'. It additionally corrects typos and makes minor non-substantive change. Its only other substantive change is to footnote 9 (at p. 15) identifying that my June 27, 2013 complaint to JCOPE, my April 15, 2013 complaint to U.S. Attorney Bharara, and my July 19, 2013 complaint to Albany County District Attorney Soares were all furnished to Governor Cuomo's so-called Commission to Investigate Public Corruption, to which D.A. Soares was a member – and that I mentioned these three complaints in testifying at its September 17, 2013 hearing.

Apologies for the inconvenience." (underlining in the original).

Above attached is the superseding complaint – and to you, too, I apologize for the inconvenience. I take this opportunity to note that only a grammatical change was made to the important paragraph (at p. 14) pertaining to

President Fogal and, inferentially, the Faculty Council of Community Colleges – which I had intended to include in my below e-mail of this morning. The paragraph reads:

"Neither Trustees Kay or Fogal or Hoyte – the SUNY Board's not 'politically-appointed members' – 'played by the rules'. There are no 'rules' permitting what they did, which was to betray their fiduciary responsibilities not only as members of the SUNY Board of Trustees, but to their constituencies of university faculty, community colleges, and students whose interests they purported to represent as presidents. They knowingly and deliberately concealed the truth of what was going on from each of their constituencies – and that truth is that they could have EASILY secured what they publicly proclaimed to have wanted: an appropriate search for a new SUNY chancellor. To achieve that goal, all it required was 'whistleblowing' about my August 14th and August 19th e-mails, which was their ethical and legal duty to do. Only conflict-of-interest, violative of Public Officers Law §74, can account for their failure to have identified those dispositive e-mails at the August 21st meeting and by their subsequent resolution and public statements." (capitalization in the original).

I request that you take this up at emergency meetings, including with the full membership of your <u>Governance</u> <u>Committee</u> – and issue a public statement as to the Faculty Council of Community Colleges' ethical, if not legal, duty going forward and with respect to the August 31st ethics complaint.
