Following up the voice mail message I left for you (646-829-4293), a short time ago, please advise as to status of my below March 14, 2018 e-mail to you pertaining to the state budget and the 2018 electoral races. Did you share the e-mail **"with WNYC's reporters whose beats are NY politics and the elections – and with their editors"**, as I had requested.

Based on my phone conversation this morning with WNYC's "statehouse reporter" Fred Mogul, who had no knowledge of who I was, prior to my call, it would appear that you did not share the e-mail with him.

Please let me hear from you, as soon as possible – the "special elections" being less than two weeks away – with Assemblywoman Shelley Mayer on the ballot to fill the Senate seat vacated by Senator George Latimer's 2017 media-rigged election as Westchester County Executive. To date, there has been NO press examination of Mayer's years of "public service" in the attorney general's office, as counsel to the Democratic Senate conference, as assemblywoman and, most importantly, as chair of the Assembly Committee on Oversight, Analysis and Investigation, duty-bound to have promptly verified the truth of my testimony at the Legislature's January 30, 2018 and February 5, 2018 budget hearings, as I expressly called upon her to do, face-to-face, both publicly and privately, as recently as March 23rd.

Thanks for your call.

As discussed, here are the links – and you should start with the last VIDEO of my testimony, on February 5, 2018 – as it is the shortest, 6 minutes, and it identifies the hundreds of millions of dollars in fraud and larceny in the Governor's combined Legislative/Judiciary budget bill for fiscal year 2018-2019 – repeating what occurred in the prior fiscal years, challenged by CJA's citizen-taxpayer actions:

Following up my below e-mail, I assume you’ve seen Reclaim New York’s February 14<sup>th</sup> “RECLAIMER” entitled “WNYC Attacks On Reclaim New York Only Shows Mission to Empower New Yorkers Is More Important Than Ever”:

It purports that “Any New Yorker who is not getting the accountability they deserve from their government can contact our regional staff, and get help. It doesn’t matter who they are, or what their exact concern may be” and that Reclaim New York is “an organization that allows anyone to pick up the phone and get help on an issue they care about”.

That is certainly NOT my experience with Reclaim New York – and I invite you to explore why this is so when CJA’s citizen-taxpayer action pertaining to the \$160 billion state budget is so squarely within the purview of what Reclaim New York purports to be about – including because it is 100% nonpartisan.

Most immediately, I urge you to watch the VIDEOS of my testimony before the Legislature about the budget for fiscal year 2018-2019, as recently as January 30<sup>th</sup>, February 2<sup>nd</sup>, and February 5<sup>th</sup> -- about which I alerted Mr. Muir on February 14<sup>th</sup>, the same day as his “RECLAIMER”. Has Mr. Muir not watched the VIDEOS? And if he has, did he not think he should promptly pick up the phone to discuss them with me. When is he planning to call me? Is he not concerned about the corruption and larceny of taxpayer money that my testimony particularized? Don’t I deserve to be “empower[ed] by his expert opinion – and to be helped by the other resources that Reclaim New York can offer? I am the co-founder and director of an unfunded, nonpartisan, nonprofit citizens’ organization, Center for Judicial Accountability, Inc. (CJA), whose use of FOIL and efforts to secure government accountability should have been embraced by Reclaim New York. This includes a citizen-taxpayer action, brought in the public interest, on behalf of the People of the State of New York, suing Governor Cuomo, Attorney General Schneiderman, Comptroller DiNapoli, the Legislature, and Chief Judge DiFiore for corruption and “grand larceny of the public fisc” with respect to the state budget – originating in fraudulent judicial and district attorney salary increases that since 2012 have stolen from New York taxpayers \$300 million. **Subject: Alerting Conservative & Republican Party Members -- & the Mercers -- of how EASY it is to achieve**

**Conservative & Republican WINS for Governor, Attorney General, Comptroller & Legislative Seats -- NO MONEY NEEDED!**

**TO: E.J. McMahon, Founder/Research Director of the Empire Center for Public Policy**

This follows up our brief phone conversation this morning, for which I thank you, occasioned by your featured attendance at the upcoming New York State Conservative Party's 51<sup>st</sup> Annual Political Action Conference – announcement of which states: “as you know, New York State elects a Governor,...Attorney General, NYS Comptroller,...and the full legislature this year.”

Below is the e-mail chain to which I referred in speaking with you. I ask that you forward it to the Mercers, from whom the Republican and Conservative parties will doubtlessly be expecting substantial funding for the 2018 elections. As detailed, NO MONEY IS NEEDED TO DEFEAT INCUMBENT STATEWIDE DEMOCRATS – CUOMO, SCHNEIDERMAN, and DiNAPOLI – OR INCUMBENT DEMOCRATIC STATE LEGISLATORS -- because ALL must be indicted for “grand larceny of the public fisc” and other corruption. The EVIDENCE is laid out by CJA's unfolding citizen-taxpayer action, to which they are ALL defendants. The four below e-mails that comprise the chain, particularize this. They are:

(1) my January 11, 2018 e-mail to Conservative Party Chair Michael Long and county chairs entitled **“ALERT to NYS Conservative Party: You can EASILY defeat Cuomo, Schneiderman, DiNapoli -- & other incumbents -- & AT NO COST”**;

(2) my January 8, 2018 e-mail to Republican Party Ed Chair Cox, separately sent to Republican party staffers and to county chairs, entitled **“Alert to NYS Republican Party: YOU CAN EASILY DEFEAT CUOMO, et al. -- & AT NO COST”**;

(3) my September 20, 2017 e-mail to then Republican gubernatorial contender Harry Wilson entitled **“Winning the Governor's Race -- & Bringing Constitutionally-Functioning, Fiscally-Accountable Government to New York State”**; and

(4) my August 10, 2017 e-mail, sent to New York's eight recognized political parties, entitled **“ OPEN LETTER: The NYS Reform Part of Curtis Sliwa MUST Rescind its Endorsement of, & Party Line to, Senator Geo. Latimer for Westchester Co. Executive & the Other Parties Must Follow Suit -- Unless They Deem Corruption in Office a Qualification”**.

The referred-to OPEN LETTER is attached above – and it is a MUST-READ, especially as the Mercers gave over one million dollars to Westchester County Executive Astorino's unsuccessful Republican and Conservative party candidacy for re-election – which Astorino and the Republican and Conservative parties could have won, *without money*, by simple whistle-blowing. Their failure to whistle-blow, combined with the flagrant election-rigging of the press, which suppressed ANY report of the August 10, 2017 OPEN LETTER, resulted in Latimer's win last November.

The “fake news” that procured Latimer's victory – involving The New York Times and Gannett, among many others – will doubtless be of great interest to the Mercers. The EVIDENCE, which

Elections are the voters opportunity to "drain the swamp". That – and the mantra of "fake news" – are what propelled Donald Trump's 2016 electoral win as president. If New York's Republican and Conservative parties are willing to "drain the swamp" of their *own* corrupt incumbent state legislators – all also defendants in the citizen-taxpayer action – they can take the three big statewide offices. And making this even more apparent are the webpages I created pertaining to Governor Cuomo, Attorney General Schneiderman, and Comptroller DiNapoli – each page also posting the countless corruption complaints against them that criminal and disciplinary authorities have been "sitting on", for years:

Republican and Conservative party leaders must not forego ousting corrupt Democratic statewide incumbents simply to "protect" corrupt and complicit Republican and Conservative legislative incumbents -- including announced Republican gubernatorial candidate Assembly Minority Leader Kolb and potential Republican gubernatorial candidate Deputy Senate Majority Leader DeFrancisco. If they would do their duty to "whistle-blow" and put up a slate of strong ANTI-CORRUPTION candidates, committed to constitutional governance and fiscal accountability, the Republican and Conservative parties could capture the top statewide elective offices, which they presently have NO HOPE to win – and win big in the Legislature, as well.

Kelly, who answered the phone, took a message from me. I stated to her that I had spoken to you requesting your assistance in sending this e-mail to the Mercers on my behalf, as likewise that I had contacted Mr. Muir, also for that purpose.

Please feel free to call me, anytime. As you are this state's foremost scholar of the budget, I so earnestly wish your expert opinion with respect to the citizen-taxpayer action – whose most devastating pleading with respect to the flagrant unconstitutionality of the state budget is its last: plaintiffs' March 29, 2017 verified supplemental complaint. And in this current environment, having President Trump in charge will scare away a lot of people - just look at the county executive races in Westchester and Nassau counties.’

**We'll see if Cox**, by this afternoon, will have some news and some names.” (bold in original).
