TO: WAMC HUDSON VALLEY BUREAU CHIEF ALLISON DUNNE

Please advise why I never heard from you, in response to my below February 22nd e-mail. Did you call or e-mail me thereafter? I have no record of same. And did you watch my below indicated and linked testimony at the Legislature's February 6, 2013 budget hearing – and examine any of the EVIDENCE posted with it?

I take this opportunity to propose – a propos of your 51% show pertaining to women – that your 2018 election coverage examine the records, in office, of New York's female state legislators with respect to public integrity/corruption issues. Why not begin with the two female legislators who were present for my February 6, 2013 testimony – Senate Finance Committee Ranking Member Liz Krueger and the now Assembly Ways and Means Committee chair, Helene Weinstein – who was then chair of the Assembly Judiciary Committee. And how about New York's then and continuing highest female legislator – Senate Minority Leader Andrea Stewart-Cousins – now poised to be Senate Majority Leader, who happens to be my senator, fully familiar with everything. And what about Senate Finance Committee Chair Catharine Young, who succeeded Senator John DeFrancisco to that position in 2015 – and before whom I testified at budget hearings both last year and this year. It is all chronicled by a mountain of my e-mail and letters to them, by the verified pleadings of the Center for Judicial Accountability's citizen-taxpayer actions, suing them for their "grand larceny of the public fisc" and other corruption, and by my testimony at budget hearings – all of which were and are accessible from CJA's website, www.judgewatch.org. Needless to say, Assemblywoman Shelley Mayer, before whom I testified on February 2, 2018 at a local forum on the state budget, should also be on your list, and especially as she will be seeking re-election to the 37th Senate district seat to which she will doubtless be elected today.
