To enable Bronx voters to vote intelligently in the upcoming elections, what reporting are you providing of the 16 Bronx state legislative seats on the ballot – beginning with the salaries to be paid to their winners? Is the salary \$110,000 – or \$79,500?

Will you ask that straight-forward salary question of Bronx's 16 state legislators – 13 running for re-election – and Bronx D.A. Darcel Clark, who is "sitting on" a public corruption/grand jury complaint against them, establishing that their \$110,000 legislative salary is the product of fraud and that the legislators have not been doing the job for which they have been paid – and, indeed, that the Legislature is not operating at a constitutional level.

The June 8, 2020 complaint, by the Center for Judicial Accountability, Inc. (CJA), is above-attached – and below are the e-mails transmitting it and the above-attached July 29, 2020 FOIL request to D.A. Clark. CJA's substantiating evidentiary webpage for the complaint is here. As stated by the complaint, Bronx voters are entitled to know that their state legislators cannot be re-elected because they must be indicted for larceny and other corruption on EVIDENCE so DISPOSITIVE as to assure their convictions. So, too, those retiring/resigned who will be pocketing *salary-based* pensions that are also larcenous.

To facilitate your asking Bronx's 16 state legislators about the complaint, I sent it to them with notice that they should be prepared for press questioning. So, too, D.A. Clark. Let them start where the complaint starts: my July 16, 2019 e-mail to Assembly Speaker Carl Heastie requesting that he and the Legislature's 14 other stipend-receiving legislative leaders forward the e-mail to the 198 other state legislators, with its attached July 15, 2019 written NOTICE and substantiating analysis proving that the December 10, 2018 Report of the Committee on Legislative and Executive Compensation – raising their legislative salaries from \$79,500 to \$110,000 – is "a **fraud** on the People of the State of New York – and a **larceny** of their tax dollars', violating a succession of penal laws, and that their duty was to void it, to return the pay-raise monies they had already received, and to initiate criminal prosecutions of the Committee's four members and abetting attorneys." The analysis is 46 pages, excluding exhibits. Will Assembly Speaker Heastie (AD-83) and his 15 fellow Bronx state legislators furnish you with their findings of fact and conclusions of law? **Five are lawyers** – Senator Luis Sepulveda (SD-32), Senator Alessandra Biaggi (SD-34), Senator Jamaal Bailey (SD-36), Assemblywoman Latoya Joyner (AD-77), and Assemblyman Jeffrey Dinowitz (AD-81). How about D.A. Clark? Will she furnish you with her findings of fact and conclusions of law? If not, I'm sure ordinary Bronx citizens would be able to help you with what is obvious. Just accompany your story with links to the complaint and the evidentiary webpage

so that they can see for themselves the open-and-shut, *prima facie* EVIDENCE that D.A. Clark has been withholding from a Bronx grand jury.

I am available to answer your questions and assist you, to the max -- on a story not only upending each and every one of Bronx's 16 state legislative races, but, additionally, ALL New York's other state legislative races and its 15 D.A. races -- and **that's for starters**.

I have also received no follow-up from your so-called "Public Integrity Bureau" – and my communications with it are reflected by the below.

As the June 8th complaint presents evidence so *prima facie* and open-and-shut as to leave no doubt that a grand jury would speedily indict – and a trial jury speedily convict – the complained-against state legislators and their accomplices, your nonfeasance – and that of your "Public Integrity Bureau" – raise reasonable questions as to how you each perform with respect to *other* public corruption complaints filed by *other* members of the public. To help answer these questions, I filed a July 29, 2020 FOIL/information request with your records access officer, to which you are cc'd. It is attached.
