To enable Brooklyn voters to vote intelligently in the upcoming elections, what reporting are you providing of the 27 Brooklyn state legislative seats on the ballot – beginning with the salaries to be paid to their winners? Is the salary \$110,000 – or \$79,500?

Will you ask that <u>straight-forward salary question</u> of Brooklyn's 27 incumbent state legislators – 24 running for reelection – and Brooklyn D.A. Eric Gonzalez, who is "sitting on" a public corruption/grand jury complaint against them, establishing that their \$110,000 legislative salary is the product of fraud and that the legislators have <u>not</u> been doing the job for which they have been paid – and, indeed, that the Legislature is <u>not</u> operating at a constitutional level.

The June 9, 2020 complaint, by the Center for Judicial Accountability, Inc. (CJA), is above-attached – and below are the emails transmitting it and the above-attached July 29, 2020 FOIL request to D.A. Gonzalez. CJA's substantiating evidentiary webpage for the complaint is <a href="https://example.com/here.c

To facilitate your asking Brooklyn's 27 state legislators about the complaint, I sent it to them with notice that they should be prepared for press questioning. So, too, D.A. Gonzalez. Let them start where the complaint starts: my July 16, 2019 e-mail to Assembly Ways and Means Committee Chair Helene Weinstein and Assembly Codes Committee Chair Joseph Lentol requesting that they and the Legislature's 13 other stipend-receiving legislative leaders forward the e-mail to the 198 other state legislators, with its attached July 15, 2019 written NOTICE and substantiating analysis proving that the December 10, 2018 Report of the Committee on Legislative and Executive Compensation – raising their legislative

salaries from \$79,500 to \$110,000 – is "'a **fraud** on the People of the State of New York – and a **larceny** of their tax dollars', violating a succession of penal laws, and that their duty was to void it, to return the pay-raise monies they had already received, and to initiate criminal prosecutions of the Committee's four members and abetting attorneys." The analysis is 46 pages, excluding <u>exhibits</u>. Will Assemblywoman Weinstein (AD-41), Assemblyman Lentol (AD-50), and their 25 fellow Brooklyn state legislators furnish you with their findings of fact and conclusions of law? **Ten are lawyers** – Assemblywoman Weinstein, Assemblyman Lentol, Senator Zellnor Myrie (SD-20), Senator Andrew Goundardes (SD-22), Assemblyman Robert Carroll (AD-44), Assemblyman Steven Cymbrowitz (AD-45), Assemblyman William Colton (AD-47), Assemblywoman Jo Anne Simon (AD-52), Assemblywoman Latrice Walker (AD-55), and Assemblywoman Tremaine Wright (AD-56). How about D.A. Gonzalez? Will he furnish you with his findings of fact and conclusions of law? If not, I'm sure ordinary Brooklyn citizens would be able to help you with what is <u>obvious</u>. Just accompany your story with links to <u>the complaint</u> and <u>the evidentiary webpage</u> so that they can see <u>for themselves</u> the open-and-shut, *prima facie* EVIDENCE that D.A. Gonzalez has been withholding from a Brooklyn grand jury.

I am available to answer your questions and assist you, to the max — on a story not only upending each and every one of Brooklyn's 27 state legislative races, but, additionally, ALL New York's other state legislative races and its 15 D.A. races — and that's for starters.
