Dutchess County's six state legislators – all running for re-election – are the subjects of a **fully-documented** public corruption/grand jury complaint, filed with Dutchess County District Attorney Grady, who has been "sitting on" it. The complaint involves the "force of law" commission/committee scheme that gave all seven of them pay raises – and a legislature not operating at a remotely constitutional level.
