Greene County's two state legislators – Senator Amedore and Assemblyman Tague, the latter running for re-election – are the subjects of a **fully-documented** public corruption/grand jury complaint, filed with Greene County District Attorney Stanzione, who has been “sitting on” it. The complaint involves the “force of law” commission/committee scheme that gave all three of them pay raises – and a legislature not operating at a remotely constitutional level.

The June 24, 2020 complaint, by the Center for Judicial Accountability, Inc. (CJA), is above-attached – and below are the e-mails transmitting it and the above-attached July 31, 2020 FOIL request to D.A. Stanzione. CJA's substantiating
