A *propos* of your yesterday's article "["Woman accusing NYC mayoral candidate of sexual assault files complaint with state AG"](#)" (May 4, 2021, Erin Durkin), featured by your today's playbook "["Stringer accuser files AG complaint"](#)", which invites "tips, suggestions, or thoughts", how about reporting on the far more consequential, *readily-verifiable*, and FULLY-DOCUMENTED public corruption complaint against Stringer and his three fellow members of the Committee on Legislative and Executive Compensation that I filed with AG James on July 15, 2019 – notice of which I gave to the Democratic mayoral candidates by the below May 1, 2021 e-mail entitled "To the whistle-blower belongs the prize -- Law Day challenge to the 'fearless, bold women' running against Scott Stringer for NYC Mayor -- & to the other Democratic mayoral candidates, as well", posted on CJA's webpage for the 2021 elections, here: <http://www.judgewatch.org/web-pages/elections/2021/menu-elections-2021.htm>.

Unlike Stringer's sexual harassment accuser, I am available to answer ALL questions – as, for instance, about the complaint's *express* request that AG James prosecute the Compensation Committee members and their *pro bono* counsel for penal law violations including: Penal Law §175.35: "offering a false instrument for filing in the first degree"; Penal Law §195.20: "defrauding the government"; Penal §190.65: "scheme to defraud in the first degree"; and Penal Law §496.05; §496.06: "PUBLIC TRUST ACT: "corrupting the government in the first degree"; "public corruption".

Where are AG James' findings of fact and conclusions of law with respect to the open-and-shut, *prima facie* EVIDENCE she has had for nearly two years? By copy of this e-mail to the Democratic mayoral candidates – Stringer among them – let them demonstrate their fitness to be mayor by demanding AG James' answer – as, likewise, answers from New York City's five district attorneys – [the Bronx DA](#), [the Manhattan DA](#), [the Brooklyn DA](#), [the Queens DA](#), [the Staten Island DA](#) – all of whom have had the EVIDENCE for nearly a year: <http://www.judgewatch.org/web-pages/searching-nys/2020-legislative/grand-juries.htm>, and from [New York City's two acting U.S. Attorneys -- for the Southern and Eastern Districts of New York](#) -- who have had the EVIDENCE since December.

Subject: To the whistle-blower belongs the prize -- Law Day challenge to the "fearless, bold women" running against Scott Stringer for NYC Mayor -- & to the other Democratic mayoral candidates, as well

TO: [Would-Be New York City Mayors Dianne Morales and Maya Wiley](#)

Each of you wasted no time in condemning Scott Stringer and calling upon him to withdraw from the race for New York City mayor based on nothing more than an accusation by a political lobbyist that 20 years ago, when she was 30 and working as a volunteer on his electoral campaign for New York City public advocate, he had sexually harassed her.

According to the Working Families Party, which thereafter withdrew its support from Mr. Stringer, in your favor, you are "fearless, bold women".

Shouldn't "fearless, bold women" have risen above their clear self-interest? Faced with Mr. Stringer's denials of this single, uncorroborated accusation – one, moreover, unconnected to his performance in office as an elected official, spanning decades – did you not believe it was your duty to stand up for the presumption of innocence to which he was and is entitled?

Quite properly, Mr. Stringer has not withdrawn from the race, despite massive defections of supporters resulting from this uncorroborated accusation, unconnected with his performance in office.

So that voters may know the kind of "fearless, bold women" you are, how about demonstrating your fitness for the office to which you would deprive Mr. Stringer? Will you "blow the whistle" on his public corruption, as New York City Comptroller, affecting ALL the People of the State of New York – as to which the PROOF is open-and-shut and *prima facie*, mandating that he be indicted. Specifically, Mr. Stringer, as New York City Comptroller, was a member of the four-member Committee on Legislative and Executive Compensation, whose December 10, 2018 report, recommending pay raises for the Governor, Lieutenant Governor, Attorney General, Comptroller and NY's 213 state legislators, was a "false instrument", violative of a succession of penal laws. This is PROVEN by a FULLY-DOCUMENTED July 15, 2019 analysis of the report by the Center for Judicial Accountability, Inc. (CJA), the non-partisan, non-profit citizens' organization of which I am director and co-founder. Indeed, the VIDEO of Mr. Stringer's behavior during my testimony before him at the Committee's November 30, 2018 public hearing is itself EVIDENCE of his unfitness for any office of public trust.

The July 15, 2019 analysis and the VIDEO of my November 30, 2018 testimony are posted on CJA's website, www.judgewatch.org, conveniently accessible from its prominent center link: "[ELECTIONS 2021 – starting with NYC's most important races – for NYC Mayor...](#)". That is where you will also find VIDEO and other EVIDENCE of public corruption by New York City mayoral candidate Brooklyn Borough President Eric Adams – as state senator – about which, as "fearless, bold women", your duty is to also "whistle-blow", lest he be elected mayor.

So that candidates Stringer and Adams can each be heard in their own defense as to this posted EVIDENCE, I am cc'ing them on this e-mail. Likewise, I am cc'ing other candidates competing in the June 22nd Democratic mayoral primary, many of whom also condemned Mr. Stringer and called for him to withdraw as a mayoral candidate. Those with

websites and e-mail addresses are Kathryn Garcia, Andrew Yang, Shaun Donovan, Raymond McGuire, Aaron Foldenauer, Esq., Art Chang, and Jocelyn Taylor. As with you, their fitness for office must also be tested by the above referred-to EVIDENCE. What do they have to say about it? To the whistle-blower belongs the prize!

I am available to answer questions and to assist every candidate – including the complained-against -- in verifying the truth of the foregoing, *readily*-accomplished from the VIDEO and other posted documentary EVIDENCE.

To further assist you, I will wait until Tuesday, May 4th, before forwarding this e-mail to New York City and statewide press. They, too, must be tested as to whether they believe that New York City voters should concern themselves with a single uncorroborated sexual harassment accusation against candidate Stringer, unrelated to his public office, but not DISPOSITIVE EVIDENCE of his public corruption and that of candidate Adams, detrimentally impacting upon the integrity and constitutionality of New York state governance. Do you?
