Three weeks ago, Daily News marketing sent a March 1, 2022 e-mail to me entitled “Special message from our Executive Editor”. Your message thanked me for “supporting local journalism” and stated “We value your feedback and want to know if you are satisfied with your subscription. If not, please tell us how we can improve.”

My response to Daily News Executive Editor Andrew Julien's request for feedback, sent 3:51 pm, March 1, 2022, via the indicated web-portal link

“Andrew, thank you for soliciting feedback. If you want to know the truth, the Daily News has, for years, and in tandem with NY's other ‘local journalism’, been covering up the readily-verifiable, in-plain-sight corruption of NYS governance and, in so-doing, has again and again rigged NY's state and local races. I can prove it -- and furnish the Daily News, under your leadership, with a treasure trove of what has been

suppressed --shaking up the 2022 races and making them competitive. The incumbents running for re-election this year include Gov. Hochul, Lt. Gov. (Bronx/Westchester), and Assembly Codes Committee Chair Jeffrey Dinowitz, Esq. (Bronx). Why don't you have a reporter ask them about my testimony. What do they deny or dispute?
