I have been a great fan of your magnificent sermons and intelligent, eloquently-expressed viewpoints, ever since December 8, 2021, when I first heard [your September 7, 2021 Rosh HaShana sermon "Reflections on Antisemitism"](#) that you dedicated to your father, Rabbi Richard Hirsch.

I am a Jew, a Zionist, and, for fifteen years, led Shabbat children services at Ansche Chesed Synagogue. I lived in Israel for four years, two as a volunteer on Sherut L'Am and, between my third and fourth year, worked at the Israel Mission to the U.N. when Benjamin Netanyahu was ambassador.

In many of your sermons you have been grappling with rising anti-Zionism and animus against Israel, most painfully, among young Jews. This is fueled, I believe, by how supposedly "trustworthy", "credible" news media falsely report and editorialize about Israel, and I have wanted to speak with you about the situation for a long time, even before I heard [your December 14, 2023 interview of Adam Nagourney about his book "The Times: How the Newspaper of Record Survived Scandal, Scorn, and the Transformation of Journalism"](#). Evident from your comments was your belief that The Times practices honest, essentially truthful journalism – and this is how Nagourney portrayed The Times both in the interview and in his book. This is flagrantly false – and I have decades of primary-source, documentary evidence of my interactions with The Times to prove it, including in the key periods about which Nagourney writes and involving many of the same people. Tellingly, among the gaping holes in Nagourney's book is that it does not examine The Times' handling of complaints about its journalism (as, for instance, pertaining to Israel, not even listed in its index), let alone examine lawsuits, such as the lawsuit I brought against The Times for "journalistic fraud", resting on the 2003 law review article "*Journalistic Malpractice: Suing Jayson Blair*

*and the New York Times for Fraud and Negligence*”, which The Times defended with litigation fraud and which was “thrown” by fraudulent judicial decisions. Did no one at The Times tell Nagourney about that [explosive, first-of-its-kind lawsuit](#), whose [March 21, 2006 verified complaint](#) opened by citing to that law review article and whose named defendants included The Times’ publisher, executive editor, managing editor for newsgathering, assistant managing editor/standards editor who had headed the review committee examining newsroom practices in the wake of the Jayson Blair scandal, editorial page editor, and first and second public editors.

Former Times journalist [Bari Weiss and her partner Nellie Bowles, who are being honored with the “Light of Freedom Award” at your May 18, 2025 benefit -- and with whom you will be “in conversation”](#) – are familiar with how The Times and other news media operate – and that politicized, conflicted academic institutions, such as at Columbia University, have covered it up – as I furnished them with the primary-source, documentary evidence by the below March 31, 2025 e-mail, attaching my above February 18, 2025 letter entitled “Defunding NPR, PBS – & Firing the CPB’s Inspector General, for starters”. As I received no responses – and their responses are crucial to the future of our democracy and to Israel – I am cc’ing them on this e-mail so that they can explain, consistent with what you so powerfully explained in your [soliloquy following your interview of Nagourney](#) that Judaism and “freedom itself rests on telling the truth” and that it is by evidence that “organized lying” and “the assault on objective truth” are repelled.

I am available to answer questions and would welcome the opportunity to do so and to thank you for so fortifying me during these difficult times for the Jewish People.

Why has Free Press published no story about the March 26th House DOGE Subcommittee Hearing “Anti-American Airwaves: Holding the Heads of NPR and PBS Accountable” – and is it not planning to?

Below is my March 28<sup>th</sup> e-mail to [Free Press](#), Uri Berliner, and River Page pertaining to the story proposal/TIP I pitched, by e-mail, on March 26<sup>th</sup> about the “Fraud & Posturing by ALL SIDES” at the hearing, proven by my [February 18<sup>th</sup> letter to House DOGE Subcommittee Chair Greene and FCC Chair Carr](#) entitled “Defunding NPR, PBS – & Firing the CPB’s Inspector General, for starters” and my e-mails transmitting it to them and, thereafter, to DOGE Subcommittee Ranking Member Stansbury, to Rank-and-File Member Gill, to NPR and to PBS. The webpage posting this primary-source, documentary evidence – including my [today’s e-mail to Congressman Gill](#) entitled “Questions about & for the Record of the DOGE Subcommittee’s March 26 Hearing...” – is [here](#).

Was my March 26<sup>th</sup> story proposal forwarded to you and to all relevant [Free Press](#) journalists, as I requested – some of whom I have here cc’d?

I have received no responses, including for a copy of Mr. Berliner’s March 25<sup>th</sup> [Free Press](#) column “[NPR Should Refuse to Take Federal Funds](#)”, so that I might be aided in my own investigations of the situation. Am I to assume that this is because Mr. Berliner and others at [Free Press](#) suffer from conflicts of interest arising from what the February 18<sup>th</sup> letter chronicles – and not only as to NPR and PBS, but as to a broad panoply of media, collusive with each other, such as [The New York Times](#) – namely, *knowingly* false, corruption-abetting, election-rigging journalism, covered-up by politicized academic institutes of supposed research and scholarship.

Is it your view – and the view of journalists comprising [The Free Press](#) staff – that my February 18<sup>th</sup> letter and e-mails do not evidence a catastrophic state of affairs that a “Free Press” committed to a “Free People” is duty-bound to investigate and report?

Please advise by the end of the day, as I have been holding off furnishing this explosive, far-reaching story to other press and commentators so as to give the LEAD to those to whom it reasonably belongs.

Below is my today’s e-mail to DOGE Subcommittee Ranking Member Melanie Stansbury, inexplicably absent from the Subcommittee’s March 26<sup>th</sup> hearing on NPR and PBS, to which I alerted you by my [March 26<sup>th</sup> e-mails](#) for investigative reporting of the “Fraud & Posturing by ALL SIDES” at the hearing.

What is the status of my March 26<sup>th</sup> ALERT-story proposal/TIP? It's now been two days and I have received not even an acknowledgment. Has it been seen by Bari Weiss – and circulated to other Free Press journalists, as I requested? PLEASE ADVISE, as I have withheld contacting other journalists, so as to give Free Press the LEAD on a story which is so in keeping with what it says about itself on its Welcome page and to which it would reasonably want the LEAD.

Certainly, it seems odd and incongruous that Free Press has not published ANY story about the March 26<sup>th</sup> hearing – apart from Mr. Berliner's March 25<sup>th</sup> column "NPR Should Refuse to Take Federal Funds". This, notwithstanding Mr. Berliner and his April 9, 2024 article "I've Been at NPR for 25 Years. Here's How We Lost America's Trust", published by Free Press, was mentioned, repeatedly, at the hearing.

The second sentence of Mr. Berliner's March 25<sup>th</sup> column starts with the words "Expect fireworks". I'm able to read only a few sentences beyond that as my first year's subscription to Free Press has expired. In exchange for the gold-mine of explosive primary-source, documentary evidence that I have furnished you by my March 26<sup>th</sup> e-mails and the below, I would appreciate if you would send me the full column.

TIME IS OF THE ESSENCE. The situation is calamitous, directly impacting on what is happening NOW with respect to New York's massive, policy-filled state budget and New York City's top electoral races, suppressed from ALL reporting by the "local journalism" of NPR and PBS stations, in tandem with New York's other press.

**NEWS TIP -- ALERT: Behind-the-Scenes of Tomorrow's House DOGE Subcommittee Hearing on NPR & PBS Bias**

Why are the NPR and PBS presidents [the only witnesses scheduled to testify at Wednesday's DOGE Subcommittee hearing on NPR and PBS bias](#)? What about the NPR and PBS public editors, each responsible for complaints, and the Corporation for Public Broadcasting's Inspector General, also responsible for complaints. And what about complainants who have filed complaints with all of them?

The importance of this was the subject of my above-attached [February 18<sup>th</sup> letter](#) to DOGE Subcommittee Chair Marjorie Taylor Greene and FCC Chair Brendan Carr entitled "Defunding NPR, PBS – & Firing the CPB's Inspector General, for starters". It opened with these two sentences:

"I am director and co-founder of the New York-based non-partisan, non-profit citizens' organization [Center for Judicial Accountability, Inc. \(CJA\)](#) and applaud your efforts to expose the truth about NPR and PBS.<sup>fn1</sup> I suggest you do so by examining how they handle complaints of biased and *knowingly* false journalism – and that you also examine how the Corporation for Public Broadcasting's Inspector General handles complaints about NPR's and PBS' handling of complaints." (italics in the original).

Nine EVIDENCE-FILLED pages later– including as to the collusion of NPR, PBS, and other media in the corruption of New York state governance involving its massive, policy-filled state budget, pay raises, NY Attorney General Letitia James, and NY District Attorney Alvin Bragg – the letter concluded, stating:

"I am available to answer questions – including under oath. I would be honored to testify at such hearings as you will be holding. In any event, I ask that this statement be submitted for the record of the hearings. I affirm it all to be true, under penalties of perjury.

Kindly forward the letter to all who are committed to establishing the truth about NPR, PBS, and their collusion with other media in 'election interference' and other violations of First Amendment responsibilities. There is much defunding, firing, and prosecutions that need to take place.<sup>fn8</sup>"

Three times I e-mailed the letter to the majority office of the House Committee on Oversight and Government Reform and to FCC Chair Carr – [February 18<sup>th</sup>](#), [February 28<sup>th</sup>](#), and [March 19<sup>th</sup>](#) – *without response*. Why was that? And was the letter forwarded to DOGE Subcommittee Chair Greene and to all the Subcommittee members? Who else? Was it forwarded to U.S. Attorney General Pam Bondi, as requested? How about to the NPR and PBS presidents and public editors and to the CPB Inspector General, for their written responses. Will it be part of the record, as requested? Will it be the subject of questioning, at all, at Wednesday's hearing?

Attached is my letter of today's date addressed to you, furnishing a mountain of evidence for defunding NPR and PBS, which their presidents will not be able to defend against at your [upcoming March hearing](#). Likewise, for firing the Corporation for Public Broadcasting's Inspector General and her deputy and counsel, who will not be able to defend against the evidence the letter presents.

To afford you sufficient time to review the letter and make strategic decisions about when to forward it to the NPR and PBS presidents so that they can prepare themselves for questioning about it and, additionally, about requiring the NPR and PBS public editors to also testify at the hearing, with statistics as to the number of complaints they receive of biased, corruption-abetting, election-rigging, fraudulent



journalism and how they handle them, indeed, whether you might want to issue subpoenas for their records, I will withhold sending my letter to them, or disseminating and publicizing it until I hear from you.

The final sentence of my letter states “There is much defunding, firing, and prosecutions that need to take place” – with an annotating footnote stating:

“...please forward this letter to U.S. Attorney General Pam Bondi, as it will greatly assist her investigations of A.G. James and D.A. Bragg, reported by [New York Public News Network reporter] Han’s February 6, 2025 article [\*“U.S. Attorney General vows to investigate two of New York’s top lawyers”\*](#), to which I cited and linked by [my February 7, 2025 e-mail](#) to her entitled “A gift to welcome you to your new job, as a Capitol News Bureau reporter for the NY Public News Network – Explosive evidence, complete unreported, about the state budget, A.G. James, & D.A. Bragg”.

I would appreciate if you will do this, as I know it will reach her more directly than my own efforts.
